#### 1. Call to Order

Chair Revoy called the meeting to order at 8:32 a.m.

#### 2. **Review and Approval of Minutes**

#### 3. **Committee Business**

#### Continue Discussion of Agenda Items for 2021

There has been no progress obtaining a Consumer Representative for the committee yet.

The CAFSAC Bylaws were sent to the committee to review the duties of the Chair and Vice Chair before voting at the July 2021 meeting.

#### 4. Community Smiles Dental Updates - Renee Ramirez, Chief Executive Officer, Community **Smiles Dental**

Renee Ramirez, CEO, and Elizabeth Sheehan, Director of Operations, provided an overview of the services provided by Community Smiles Dental. The main focus is to provide services to low income families that have difficulties getting access to dental care due to being on Medicaid, low income, or uninsured. Some of the services include:

- Cleanings twice a year for children
- Urgent Care
- Services for patients, including adults, with special needs
- Special programs for pregnant women

Cherone arrived at 9:05 a.m.

Community Smiles Dental serves Ozaukee, Washington, Milwaukee, and Waukesha counties.

Currently, the Waukesha clinic services for adults is primarily for emergencies. If other services are needed, the clinic can make a referral. The Menomonee Falls location has services for adults that include comprehensive exams, dental cleanings, simple restorations, and simple extractions.

If adults are experiencing pain or have a dental emergency, they can be seen for a limited oral exam at either the Waukesha or Menomonee Falls location. Each location has a limited availability for emergency appointments each day.

### 5. Committee and Organization Updates

#### a. HHS Board Liaison

Menefee reported that the HHS Board is currently working on the budgets. There is a new program that is currently in the planning stages called Women's Health and Recovery Project (WHARP). It is a program for women and children during the recovery process. The next Board meeting is June 17.

#### b. HHS Staff Liaison

Mullooly announced that Penny Nevicosi will be starting on July 12 as the new Child and Family Services Division Manager.

#### i. COVID-19 Updates

Pupp reported that the mass clinic that was previously held at the Expo Center has been closed. The vaccinations are now being handled by private practitioners and pharmacies.

### c. Schools

Villarreal stated that Mukwonago schools have made masks optional. Mukwonago High School is still offering virtual options for next school year; however, the virtual options are not available through the school district for younger students.

### 6. Discussion of the Mask Policy at Different Agencies

Attendees discussed the mask policies at their agencies, including:

- At Elevate, staff meetings are primarily being held in-person but have the option to do
  them via Zoom if necessary. If the meeting is in-person, staff is to come to the meeting
  wearing a mask and then the group can make the decision of wearing them through the
  entirety of the meeting or not.
- Easter Seals is requiring staff to turn in their vaccination card in order to not be required
  to wear a mask. If the individual is in their cubicle or private office by themselves, they
  can have their mask off, even if they are not vaccinated. Easter Seals is also surveying
  their clients for in-person meetings to find out if they are having COVID symptoms. If they
  respond yes, the meeting will be held virtually or another option.
- At ProHealthCare, Inc. all employees are required to wear a mask while in the clinics or general hospital areas. Patients and visitors are also required to wear a mask until they are in their own hospital rooms. Once in the rooms, they are able to take the mask off until they leave the room again.
- Family Service is no longer requiring masks but encourages unvaccinated individuals to continue wearing them. For in-person meetings, the therapist or meeting organizer is in

- charge of making the decision of whether or not a mask will be required. If the therapist or organizer wants masks to be worn, the client must wear them.
- At LifePoint Church, it is up to each individual if they want to wear a mask or not.
- Parent's Place, Inc. is no longer mandating masks but still recommends wearing them. The 24-hour symptom policy is still in effect and virtual options are available for those having symptoms.

## 7. Agency Updates/Announcements

The Women's Center (TWC) support groups are back to meeting in-person. A teen retreat will be held on June 26. There will be a session on prevention and resources on human trafficking in August. TWC continues to be available for in-person or virtual presentations or trainings.

NAMI Southeast Wisconsin is offering basics classes for parents or caregivers who have a child under the age of 18 who is affected by a mental health condition. The next class is August 26 and will be held virtually.
