## Approve Minutes from May 12, 2021 Meeting

## Status of Pretrial Supervision and Pretrial IDIP Caseloads and Waitlists

Eiring reported that the IDIP caseload has 130 participants; Pretrial Supervision has just under 100 participants. Eiring is unsure of the reason that Pretrial Supervision is not being utilized more often. WCS will be resuming preliminary breath tests on June 21.

The group agreed to remove this topic from future agendas, as pretrial supervision caseloads have been relatively stable for several months. The agenda item will be added again, if/when needed.

## Overview of State Public Defender (SPD) Request for Research by Marquette University on Pretrial Detention in Waukesha County

Perri provided a brief background regarding the events and discussions that prompted the research request. Perri reviewed a document titled "Report on Waukesha Pretrial Detention and Bail Bond Process; Final Report to the Waukesha County State Public Defender's Office; March 5, 2021."

Dorow stated that most of the information analyzed by the professors, such as race, is not information that is provided to the judges for weekend Riverside reviews. The information that is provided to the judges for weekend Riverside reviews is *extremely* limited.
