



NOTICE AND ORDER FOR ALL CRIMINAL CASES (CF) AND (CM)

WHEREAS, the World Health Organization declared a global pandemic of Coronavirus Disease 2019 (“COVID-19”) due to widespread human infection worldwide, and Wisconsin Governor Tony Evers and Waukesha County Executive Paul Farrow have declared public health emergencies, respectively, for the State and County of Waukesha;

Pursuant to this Court’s Standing Order, 20-SO-20 (67), dated April 27, 2020, Relating to the Status of Pending Criminal/Traffic Proceedings, in order to assess and prioritize pending criminal cases in an effort to maintain order and protect individual’s rights to access to justice, the Court ordered the completion of a Criminal Status Sheet.

NOW THEREFORE, IT IS ORDERED that defendants or their counsel in each case pending in the Criminal/Traffic Division shall be required to complete and file a Criminal Status Sheet within 21 days from receipt of the form. (A copy of the form is attached hereto).

IT IS FURTHER ORDERED that if you are unrepresented, you should contact the District Attorneys’ Office at (262) 548-7076 to speak to the assigned Assistant District Attorney on your case prior to filling out the attached form. Completed forms can be eFiled, mailed to Criminal Traffic, P.O. Box 1627, Waukesha, WI 53188 or placed in the drop box located at the front entrance inside the Waukesha County Courthouse, at 515 W. Moreland Boulevard, Waukesha, Wisconsin.
