# MODIFY THE WAUKESHA COUNTY SHERIFF'S DEPARTMENT 2020 BUDGET TO ACCEPT THE 2020 STATE OF WISCONSIN DEPARTMENT OF MILITARY AFFAIRS EMERGENCY POLICE SERVICES GRANT AND AUTHORIZE GRANT EXPENDITURES

WHEREAS, the State of Wisconsin, Department of Military Affairs, Division of Emergency Management has identified the need to increase the State's ability to respond to civil disturbances by providing funds to police agencies to purchase equipment to allow them to respond to these disturbances; and

WHEREAS, the Waukesha County Sheriff's Department has an established, multi-jurisdictional Civil Disturbance Unit; and

WHEREAS, the Waukesha County Sheriff's Department applied for and received \$8,321 in grant money to fund the purchase of additional equipment to assist with civil disturbance response; and

WHEREAS, the Waukesha County Sheriff's Department is proposing to modify the 2020 adopted budget by increasing the operating expenditure appropriation unit by \$8,321 to allow for the purchase of grant eligible equipment purchases for the Civil Disturbance Unit.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Sheriff's Department be authorized to accept the Wisconsin Department of Military Affairs Emergency Police Services Mobile Field Equipment grant to fund equipment purchases for civil disturbance response.

BE IT FURTHER ORDAINED that the Waukesha County Sheriff's Department 2020 budget be modified by increasing intergovernmental revenues by an additional \$8,321, and increasing the Department's operating expenditure appropriation unit by \$8,321 to fund equipment purchases for civil disturbance response.
