WHEREAS, the County Board voted at its February 23, 2021 meeting to establish a supervisory district map with 25 districts; and

WHEREAS, in drawing the district map, counties rely on redistricting data sets from the Census Bureau; and

WHEREAS, the COVID-19 pandemic caused the Census Bureau data to be delayed and census block data was received on August 16, 2021; and

WHEREAS, a tentative supervisory district plan with 25 districts and boundaries was made public on August 19, 2021; and


WHEREAS, requisite notice of a September 13, 2021 public hearing was given.
