ESTABLISH SALARIES FOR COUNTY CLERK, REGISTER OF DEEDS, AND TREASURER FOR 2025 - 2028

WHEREAS, the Waukesha County Code of Ordinances states that the County Clerk, Register of Deeds, and Treasurer shall receive salaries as determined by the County Board; and

WHEREAS, the next four-year term of office for the County Clerk, Register of Deeds, and Treasurer will begin in 2025; and

WHEREAS, pursuant to Wisconsin State Statutes, any changes in compensation must be adopted in advance of processing nomination papers and the election; and

WHEREAS, reasonable salaries are necessary to attract qualified candidates to these full-time elected department head positions; and

WHEREAS, per Wisconsin law, the County Clerk, Register of Deeds, and Treasurer cannot participate in the County performance management compensation program; and

WHEREAS, a 7% salary increase is appropriate for the Register of Deeds in 2025 and, for internal equity purposes, an 8.4% salary increase is appropriate for the County Clerk and the Treasurer in 2025 to be in alignment with the Register of Deeds; and

WHEREAS, a 3% salary increase is appropriate for the County Clerk, Register of Deeds, and Treasurer in 2026, 2027, and 2028.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS, that effective January 1 of each calendar year, the annual salaries of the County Clerk, Register of Deeds, and Treasurer shall be:

The chart below details the estimated annual fiscal impact of the elected official salary adjustments proposed in the ordinance. The ordinance would approve salary increases in 2025 for the Register of Deeds of 7%, for the Treasurer of 8.4%, and for the County Clerk of 8.4%. For 2026-2028, this ordinance approves salary increases for all three elected officials by 3% annually.
