AUTHORIZATION TO ENTER INTO SETTLEMENT AGREEMENT IN THE CONDEMNATION LAWSUITS AGAINST WAUKESHA COUNTY BROUGHT BY GREGORY BACKUS, VALERIE ZOREK, JAMIE SHIRLEY AND NICHOLAS BROCK

WHEREAS, Waukesha County undertook a highway project (Project ID 2788-00-22) to reconstruct and improve the West Waukesha Bypass in the City and Town (now Village) of Waukesha; and

WHEREAS, as part of the highway project, the County acquired by eminent domain, temporary limited easements for construction purposes on lots owned by several adjacent landowners in the Heritage Hills Subdivision in the City of Waukesha, specifically Gregory Backus, Valerie Zorek, Jamie Shirley, and Nicholas Brock (hereinafter "the Landowners"); and

WHEREAS, pursuant to Chapter 32 of the Wisconsin Statutes, the Landowners have appealed the Award of Damages to the Circuit Court for a determination of just compensation to be paid for the taking of the property in corresponding Case Numbers 18-CV-1379, 18-CV-140, 18-CV-1739 and 18-CV-142; and

WHEREAS, the Landowners have each also filed separate lawsuits against Waukesha County and the State of Wisconsin, Department of Transportation ("DOT") seeking monetary damages and other relief for an alleged change of grade and inverse condemnation in corresponding Case Numbers 21-CV-591, 21-CV-590, 21-CV-594, and 21-CV-592; and

WHEREAS, both lawsuits filed by each Landowner have been consolidated under the 2018 Case Numbers (hereinafter "the Litigation"), and pursuant to orders of the court, all parties have attended mediation sessions, and

WHEREAS, through mediation, Waukesha County, DOT and the Landowners have reached a global, settlement agreement on August 1, 2023, the terms of which are conditioned upon County Board approval; and

WHEREAS, the continuation of the Litigation causes substantial financial risk to the Landowners, Waukesha County and the DOT; and all parties will incur additional, significant expenses if a settlement of the Litigation is not reached at this time; and

WHEREAS, it has been determined that settlement of the Litigation at this time is in the best interest of Waukesha County.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the settlement in the condemnation Litigation against Waukesha County brought by Gregory Backus, Valerie Zorek, Jamie Shirley and Nicholas Brock, Case Numbers 18-CV-1379, 18-CV-140, 18-CV-1739 and 18-CV-142, respectively, is approved according to the terms of the settlement agreement, which was previously shared with the County Board in closed session.
