

ENROLLED ORDINANCE 178-79

CREATE ONE REGULAR FULL-TIME SPECIAL PROSECUTOR, ONE REGULAR FULL-TIME SENIOR ADMINISTRATIVE SPECIALIST, AND ONE REGULAR FULL-TIME VICTIM WITNESS SPECIALIST IN THE DISTRICT ATTORNEY'S OFFICE WITH A SUNSET PROVISION OF DECEMBER 31, 2024

WHEREAS, the 2024 District Attorney County General Fund Budget was amended to appropriate unallocated American Rescue Plan Act funds to support additional staff coverage for the sixth criminal court and victim/witness services; and

WHEREAS, these funds are temporary in nature needing to be committed by year-end 2024; and

WHEREAS, the adopted 2024 County Budget included Finance Committee Amendment-1 which explicitly stated these positions be created with a sunset provision terminating on December 31, 2024.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that effective January 1, 2024, one regular full-time Special Prosecutor, one regular full-time Senior Administrative Specialist, and one regular full-time Victim Witness Specialist in the District Attorney's Office with a sunset provision of December 31, 2024, are created.




