REQUIRED CANDIDACY FORMS

1. CAMPAIGN FINANCE REPORT (EL-163)

- MUST BE FILED BEFORE ACCEPTING ANY DONATIONS AND BEFORE SPENDING ANY MONEY
- MUST FILE FORM – EXEMPTION ELECTION NOW AT \$2,000
- CAN BE FILED NOW
- DUE BY JUNE 1ST BY 5:00 PM TO THE WAUKESHA COUNTY CLERK'S OFFICE

2. DECLARATION OF CANDIDACY (EL-162)

- CAN BE FILED AT ANY TIME
- DUE BY JUNE 1ST, 2020 BY 5:00 PM TO THE WAUKESHA COUNTY CLERK'S OFFICE

3. NOMINATION PAPERS (EL-169)

- MINIMUM SIGNATURES – 500
- MAXIMUM SIGNATURES – 1000
- CANNOT START CIRCULATING PRIOR TO 4/15/2020
- SIGNER MUST BE A RESIDENT OF WAUKESHA COUNTY
- DUE BY JUNE 1ST, 2020 BY 5:00 PM TO THE WAUKESHA COUNTY CLERK'S OFFICE
