## Highlights from the Past Month. . .

**Teaming up for a Cause:**

On April 23<sup>rd</sup> the AIS team was accompanied by a class from Carroll University. With the students' help, over 50 purple loosestrife plants were uprooted and transferred to The Prairie Springs Environmental Education Center that is a new addition to Carroll! These plants will be used to grow biocontrol beetles that eat purple loosestrife and have been proven to reduce plant populations. These beetles will then be released into large patches of purple loosestrife around Waukesha County in effort to suppress the growth and spread of this invasive throughout the county.



After the group collected purple loosestrife, they headed out to Little Muskego to collect starry stonewort bulbils. The group strapped on their waders and were equipped with throw-able rakes and buckets to wrangle up very small and elusive bulbils. Bulbils are the reproductive, seed-like structures that can spread and start growing elsewhere. The collected bulbils can be studied in laboratories to suppress the growth and spread of this species. Starry stonewort is a new invasive to Wisconsin and is only found in a few lakes in SE Wisconsin.

### **Partnerships:**

Since the beginning of the year our team has been working with SEWRPC to develop a strategic plan. One of the beginning stages of the project included going to all the boat launches and known fishing piers in the county and documenting where they are, how many parking spaces and invasive species were present at the launch. We took pictures of what signs were posted at each launch and the launch condition. With this data, SEWRPC can develop crucial information to add to the strategic plan. The pictures will be used to make a future story map that will be posted later this year! Stay tuned for more information.
