

What Chemicals are Acceptable?

Virtually all damaged or unwanted chemicals including:

- **Pesticides:** herbicides, insecticides, fungicides, rodenticides including silvex, atrazine, 2,4-D, captan, malathion, DDT, parathion, chlordane, lindane, 2,4,5-T
- **Chemicals include:** lead arsenate, wood preservatives, creosote, penta, lead and oil paint, solvents, wood finishes, acids, oxidizers, pool chemicals and sanitizers, engine degreasers, parts cleaners, acid washes.

Unacceptable Materials

- Explosives, including detonators and blasting caps
- Radioactives, including smoke alarms
- Infectious and biological wastes
- Freon 11 and 12
- Propane tanks and cylinders
- Waste oil (take to recycling site)
- Latex paint

Your business or organization is fully liable if an employee or customer is harmed by waste chemicals or if waste chemicals leak into the environment.

Who Can Participate?

Active and inactive farms, businesses,
government, schools in Waukesha County.
Also co-ops, golf courses, right-of-way
applicators, aerial applicators, landscape
companies, retail stores, real estate
management companies, and others.

Farms and Farm Properties

Any operating farm or inactive farm is
eligible for free disposal for up to 500
pounds of farm chemicals. Farmers may be
required to pay for amounts over 500
pounds, depending on grant budget.

Businesses and Institutions

DATCP offers a 50% disposal subsidy for
waste pesticides only. Businesses must pay
the remaining balance. A price quote will be
provided based on the pre-registration
inventory.

How to participate - Easy as 1, 2, 3

1. Pre-Register *at least 5 business days in advance*

2. Estimate the types and quantities of materials for disposal. **Businesses** fax form to the waste contractor. **Farms** return form to the County.

3. Receive confirmation of drop off location and date. Bring in materials.

Handling Precautions

- Materials should be properly identified in
their original containers with original labels,
if possible.
- **Do not mix substances together!**
Doing so can be extremely dangerous.
- **Visually inspect containers** before lifting
or moving them.
- **Secure all lids, caps and covers** before
lifting or moving.
- **Never place hazardous chemicals in the
passenger compartment of vehicles.**
Transport in the trunk of cars or the bed of
trucks.
