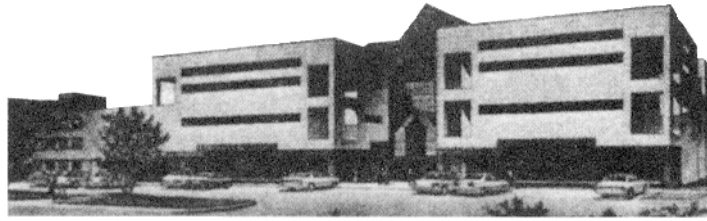

UPDATE

Since November 8, 2018, the Waukesha County Sheriff's Office had been actively attempting to locate and arrest Jonathan Pogreba on outstanding felony warrants. Jonathan Pogreba removed his GPS monitoring bracelet and fled the State of Wisconsin.

On December 11, 2018, the Village of Mukwonago Police Department arrested Jonathan Pogreba on outstanding warrants in the Village of Mukwonago and he was booked into the Waukesha County Jail.

This remains an ongoing investigation by the Waukesha County Sheriff's Office and no additional comment is available at this time.

On 6-21-2018, the Waukesha County Sheriff's Office arrested Jonathan Pogreba without incident on outstanding warrants at the Waukesha County Courthouse and he was booked into the Waukesha County Jail. This remains an ongoing investigation.

On the evening of 6-7-18 we were notified by Trempealeau County Sheriff's Office that they believed Jonathan Pogreba broke into a cabin in their area.

The Waukesha County Sheriff's Office was advised by Trempealeau County Sheriff's Office that they received a report of a hunting cabin that appeared to have been broken into. The cabin is located in the town of Preston, Trempealeau County, southeast of the city of Blair. The caller, a neighbor to this property, reported that he talked to the owner of the cabin and was told that no one should be at the cabin. The Trempealeau County Sheriff's Office also spoke to the owner of the cabin and confirmed this information. The owner of the cabin is related to Jonathan Pogreba and does not live in Trempealeau County.

Trempealeau County Sheriff's Office with the assistance from the Blair Police Department responded to this location and found that someone broke into the cabin and it appeared that they have since moved on. Based on the evidence located in the cabin, the Waukesha County Sheriff's Office believe the person that broke in was Jonathan Pogreba. There was a small amount of blood left at the cabin so Jonathan may be injured and a note was left that we believe came from Jonathan.

In the note, Jonathan stated that he took the plates off the white BMW that he was driving and would be travelling to the Boundary Waters in Minnesota where he would leave the car and move out on foot.

Jonathan Pogreba's credit card was used in Mauston, WI and we are attempting to gather more information on his financial purchases at this time.

Please call 911 if you believe you see Jonathan Pogreba or the vehicle he is driving. Do not attempt to stop Jonathon Pogreba yourself. He is still believed to be armed and dangerous, and possibly injured.

If you have had any contact with Jonathan Pogreba since June 5, 2018, have seen the vehicle or have any information regarding the whereabouts of Jonathan Pogreba please contact the Waukesha County Sheriff's Office tip line at 262-896-8139. Thank you for your help in this matter.

6-7-18

We have currently set up a tip line for any information coming in on this investigation. If you have information that you believe could be helpful, please call 262-896-8139. If you believe you see the vehicle or Jonathan Pogreba please call 911.

The Waukesha County Sheriff's Office continued following up on information that was received throughout the evening. During that continued investigation it lead us to a home about one half mile south of the Pogreba residence where we believe Jonathan Pogreba stole a vehicle.

The vehicle that Pogreba is believed to be driving is a 2015, white, BMW 328XI, 4-door sedan with WI registration plates of 128-YCW. (Pictures attached)

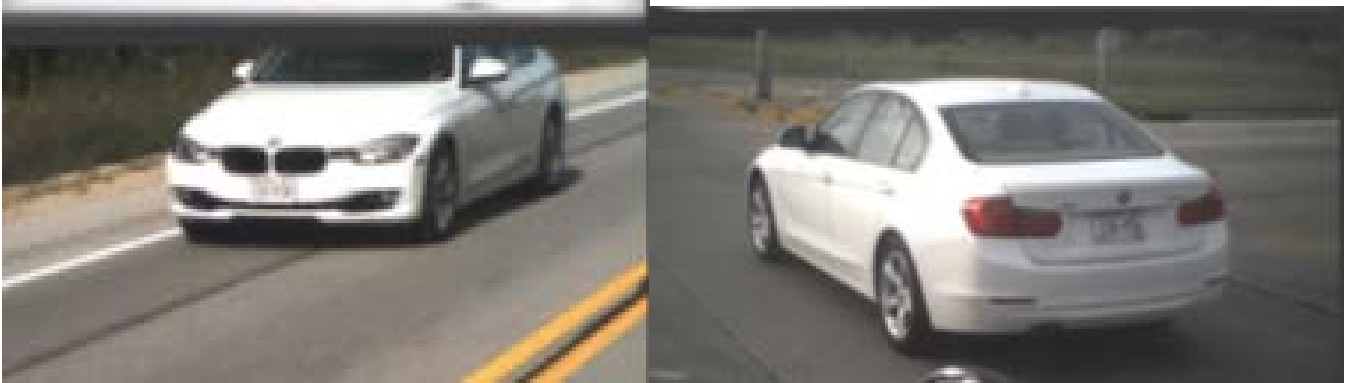
Jonathan Pogreba was last seen wearing a blue t-shirt, dark jeans, black tennis shoes with white trim and a black baseball hat with yellow lettering. We believe he may be headed to the La Crosse area or possibly Minnesota where he is known to have acquaintances.

6-6-18

The Waukesha County Sheriff's Office has conducted a thorough search of the entire area for Jonathan Pogreba. We have reason to believe that Jonathan is no longer in the Waukesha County area and the incident remains under investigation.

The Waukesha County Sheriff's Office holds a valid felony warrant for Jonathan with a \$100,000.00 cash bail. Jonathan is still believed to be armed and dangerous so do not approach him on your own.

6-6-18

Efforts are underway again this morning as we continue searching for Jonathan Pogreba. At this point he has not been located and remains out in the community.

We have learned, during this domestic incident, that gunfire was exchanged between family members. None of the family members that we have had contact with have been injured by gun fire. We have not been able to confirm whether or not Jonathan Pogreba has been injured. It is possible that he may be, but again, we have not been able to confirm that. We do believe he is still armed and dangerous.

On June 5th we were assisted by the following agencies with this incident; State Patrol with air support as well as several Troopers, DNR Wardens, City of Waukesha Police Department with their Tactical

Enforcement Unit and Drone Support, Greenfield Police Department with Drone Support, West Allis Police Department with K9 Support, Village of Menomonee Falls, North Prairie and Summit Police Departments as well as the North Prairie & Eagle Fire Departments. Thank you all for your assistance and support throughout the night.

6-5-18

On Tuesday, June 5, 2018, at approximately 2:51 PM, the Waukesha County Sheriff's Office received a call regarding an incident involving a man with a gun.

Based on witness statements, it is believed that this is a domestic related incident that occurred between a husband and wife. A weapon was fired and we are attempting to locate the suspect.

This incident occurred at an address on Wilton Road west of Highway 59 in the Town of Eagle. We are still looking for one of the subjects involved in this incident. His name is Jonathan Pogreba, he is a 43 year old white male, approximately 6 foot tall and about 210 pounds. He was last seen wearing a "dirty" white shirt and blue jeans. This subject is believed to be armed and dangerous. If you see someone matching that description, please call 911.

This remains an active investigation and we are requesting that everyone stay clear of the area at this time.
