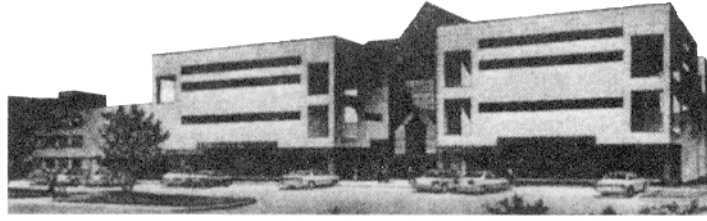

UPDATE

We want to thank all of the individuals in the community for coming forward with information and/or video that was provided to our department regarding the officer-involved shooting that occurred in Milwaukee County on Lincoln Memorial Drive on Sunday, 6-11-17.

We greatly appreciate the support from the public in assisting us with this information. In an effort to be as thorough as possible, we want to make sure we have all the information and evidence that may exist. If you are a witness or have any video that maybe helpful to our investigation, please contact us.

Additionally, we are asking that anyone who may have pictures or video from the area of the Northpoint Custard Stand on Lincoln Memorial Drive, facing south toward the shooting, please call us.

We are also aware that a drone pilot was operating a drone in that area at the time of the shooting. We are asking that the drone pilot please contact us as soon as possible so we can add that information as it may be beneficial to our investigation.

On Sunday, June 11, 2017, The Waukesha County Sheriff's Office was requested by the Milwaukee County Sheriff's Office to investigate an officer-involved shooting that occurred near the intersection of Lincoln Memorial Drive and Water Tower Rd in the City of Milwaukee.
