SUMMARY TO DA

In Custody Death of Clarence Wilson

This report will serve as the summary of the In Custody Death (ICD) investigation of inmate Clarence Wilson that occurred on 08/29/17 at 2255 hours at the Milwaukee County Jail located at 949 N 9th Street in the City of Milwaukee.

Wilson had been assigned to Pod 3B, Cell #43, at the Milwaukee County Jail when he began to suffer from an unknown medical emergency. Wilson was treated by jail and medical staff in the pod and later transported to the Jail Medical clinic where he was declared deceased by the Milwaukee Fire Department. The Waukesha County Sheriff's Department (WKSO) was contacted and requested to respond as the lead investigative agency per Milwaukee County Sheriff's Department (MCSO) department policy.

Upon arriving at the Milwaukee County Jail, Captain Patrick Esser along with Detectives Hoppe, O'Toole, Jensen, and Kropp met with Deputy Inspector Aaron Dobson, Lt. Steven Haw, Lt. Tricia Carlson, Detective JoAnn Donner, and Detective Andrew Halstead from the Milwaukee County Sheriff's Department (MCSO), Milwaukee County District Attorney Investigator's Linden and Gibson, and Hillary Donald from the Milwaukee County Medical Examiner's Office.

During the meeting all members in attendance were briefed on the following information:

Wilson had been taken into custody by the Milwaukee Police Department on 08/28/17 at 2046 hours for a Probation Violation after a urinalysis test conducted at his residence resulted in a positive indication for cocaine. Wilson was transported from his residence to Columbia St. Mary's hospital after complaining of arm pain during the arrest. Upon being medically cleared from Columbia St. Mary's at 0025 hours on 08/29/17, Wilson was transported to Milwaukee Police Department District #3 at 0056 hours to complete the booking process. Wilson was then transported to the Milwaukee County Jail arriving at 0200 hours. Wilson was booked and assigned to Pod 3B Cell #43 at 1025 hours on 08/29/17.

Near the end of the second shift (1400-2230) on 08/29/17, Correctional Officer Cristal Jackson called for an unknown medical emergency over her jail issued radio at 2156 hours. Wilson was immediately provided medical treatment and was transported to the Jail Medical Clinic while awaiting transport to a local hospital by EMS for further medical treatment. During this time, staff determined that Wilson was not breathing and did not have a pulse. CPR was administered and the use of an AED was attempted by staff until the Milwaukee Fire Department arrived on scene who continued resuscitation efforts in the Medical Clinic. After consulting with a physician at Froedtert Hospital, Wilson was pronounced deceased at 2255 hours on 08/29/17.

MCSO staff stated that there was no obvious injuries to Wilson and there were no concerns reported by jail or medical staff prior to the medical emergency. Wilson was in a single person cell at the time of this incident and the pod was in lockdown status at the time of the emergency. MSCO Supervisory staff informed WKSO Detectives that all MCSO and medical staff members involved in the incident were still in the jail and were waiting to be interviewed.

Surveillance Video

Surveillance video was later obtained from the following locations: Officer Bradford's body camera (Arresting Officer on 08/28/17), Milwaukee Police Department District #3 Sally port, District #3 Fingerprint room, District #3 Booking area, District #3 Adult Cells holding area, Milwaukee County Jail (MCJ) Sally port, MCJ Pre-Book and search area, MCJ Booking area, MCJ Pod 3B, MCJ Pod 3B Vestibule Clinic, MCJ Pod 3B gym, MCJ Hallway from 3rd floor elevator to Pod

Crime Scenes- Pod 3B and Medical Clinic overview WKSO Detectives requested to observe the area where Wilson was housed. WKSO Detectives Hoppe, O'Toole, and Jensen along with DA Investigators Linden and Gibson, AND Medical Examiner Staff were escorted to Pod 3B and a review of the housing and security system was conducted. Wilson's cell had been secured and had crime scene tape along the edges of the door.

Pod 3B and cell #43 overview

Detective Kropp proceeded to take overall photos of the pod and the exterior of Wilson's cell prior to entering. After Detective Kropp had completed taking the necessary photos, entry to the cell was made by Detective Kropp and Investigator Linden. I did enter the cell and reviewed the contents and set up of the interior of the cell. I did not observe anything suspicious nor did there appear to be anything out of the ordinary. Detective Kropp confirmed that the sink in Wilson's cell had running cold water. It was learned later in the investigation that toilet is on a timed flushing system and if someone attempts to flush the toilet multiple times prior to the original activation of the flushing system it will shut off to avoid inmates flooding their cells. This would be the reason that Detective Kropp was unable to activate the flushing feature as noted in his supplement. Hillary Donald (ME'S Office) was able to later confirm that the toilet was in fact able to flush and it does appear that there was no issues with the plumbing or access to water in Wilson's cell. Detective Kropp documented the items in Wilson's cell, which consisted mostly of jail issued property and a left over jail issued bag lunch with remnants of food inside of it. Detective Kropp did confirm that the intercom in the cell was functioning properly by activating it while he was inside of the cell. Once it was activated, Detective Kropp heard the audible alarm coming from the Officer Station terminal ensuring it was functioning at the time.

There did not appear to be anything suspicious or out of the ordinary in Wilson's cell according to Detective Kropp or Hillary Donald.

Medical Clinic

Afterwards, staff was escorted to the Medical Clinic where Wilson's body was still located. Detective Kropp again took overall photos of the scene as Detectives observed the area. Wilson was lying on his back just a few feet inside the main entry door to the clinic. Wilson's feet were facing towards the door leading to the clinic with his head facing the hallway of the clinic. There was an AED nearby along with a RIP restraint belt that appeared to be cut lying near Wilson.

Interviews

At that time it was decided that Detectives would begin interviewing staff involved, while Detective Kropp completed processing both scenes (Pod 3B and the Medical Clinic) and collecting evidence along with staff from the Milwaukee County Medical Examiner's Office. Video surveillance from the Milwaukee County Jail was later obtained and reviewed for records purposes.

Detectives from WKSO and MCSO conducted interviews with MCSO jail staff, inmates

located in Pod 3B, and with medical staff who were involved.

Summary of Interview with Correctional Officer Cristal Jackson ASN to Pod 3B:

The first interview conducted was with Correctional Officer Cristal Jackson. The interview was conducted in the Administration Conference room located at the Milwaukee County Jail. DA Investigator Linden was present during the interview which was recorded. During the interview C.O. Jackson stated that she was assigned to Second shift 1400-2230 hours and was assigned to inmate housing unit 3B during her shift on 08/29/17. C.O. Jackson stated that it was a routine shift and she relieved C.O. Benjamin Giese who briefed her on one inmate that had been removed from the pod for disciplinary reasons and one other inmate who had been suffering from heroin withdrawal, neither of which were Wilson. C.O. Jackson then informed us she had no interaction with Wilson prior to the medical emergency call and was unable to even recall observing Wilson during the evening since "older inmates usually keep to themselves". C.O. Jackson began the process of locking the inmates down for the evening at 2053 hours, which consists of lining up the inmates and confirming wristbands and housing unit cards match. Shortly after securing the inmates in the pod at 2059 hours, a nurse arrived in the pod and conducted med pass to several inmates. C.O. Jackson admits that she was supposed to log the nurse in and out of the pod in her activity log but believed she forgot to log the nurse out of the pod, which would have been proper protocol. C.O. Jackson admitted to felling rushed and also received five new inmates at 2115 hours. C.O. Jackson logged the new inmates into the computer system and exited her pod at 2126 hours. C.O. Jackson admitted that she is supposed to turn over control of her pod to floor control

prior to exiting her pod since there would not be an officer inside the pod to answer any emergency calls, but acknowledged that she did not complete this task. C.O. Jackson gave no reason for not turning over control of the pod to floor control and stated she simply did not do so. C.O. Jackson then completed her paperwork and spoke with Officer Shondel Thompson at floor control before entering her pod at 2155 hours to conduct her final check. Upon entering, C.O. Jackson described being immediately alerted by all of the inmates that cell 43 (Wilson's cell) needed help. C.O. Jackson rushed to Wilson's cell and observed Wilson lying on his bunk yelling "I can't breathe". C.O. Jackson then called a medical emergency for Wilson and went back to the Officer Station to allow other Officers entry into the pod. C.O. Jackson stated that several Officers responded and once additional staff were on scene, she unlocked Wilson's cell door and observed while Wilson was provided treatment by jail and medical staff. C.O. Jackson recalled Wilson moaning and yelling "help me" during this time. C.O. Jackson did not provide any other assistance during this time, due to monitoring the Officer Station and controlling the doors in the pods. C.O. Jackson stated that as she returned to her Officer Station she observed that "all of the other inmates" emergency intercoms were activated on her computer indicating she had not turned over control of the pod to floor control prior to exiting her pod at 2126 hours. C.O. Jackson again gave no reason for not turning over control, indicating she is aware that it is MCSO policy that control should be turned over when nobody is in the pod monitoring the inmates while they are secured in their cells. C.O. Jackson also repeated that she had no interaction with Wilson throughout the evening and was never made aware of any medical problems Wilson may have been suffering from. This concludes the summary of the interview with C.O. Jackson.

Summary of interview with Lieutenant Steven Haw

Lt. Haw was interviewed next and was interviewed in the Jail Administration Conference room located at the Milwaukee County Jail on the morning of 08/30/17. The interview was recorded with Lt. Haw's permission. Lt. Haw stated that he is assigned to second shift, 1330-2200 hours, and had been working the night of 08/29/17. Lt. Haw stated that he was assigned to the Booking area and was preparing to end his shift when he heard C.O. Jackson call for a medical emergency in Pod 3B. Lt. Haw responded and observed Wilson in his cell. Lt. Haw noted that Wilson was moving his arms and legs but he could not hear what Wilson was saying. Once additional Correctional Officers arrived, the door to Wilson's cell was opened and he was placed on the floor in front of his cell. Lt. Haw was still not aware of the reason for the medical call but due to Wilson flailing his arms and legs, wrist restraints were placed on him and staff was holding down his legs while RN Markwardt began her initial assessment of Wilson. Lt. Haw described Wilson as "thrashing around during this time". Lt. Haw did overhear RN Markwardt state that Wilson's "Pulse Ox was 72". At 2208 hours RN Markwardt requested the Milwaukee Fire Department (MFD) be called to transport Wilson to a hospital. Wilson was then placed in a wheelchair and transported to the Medical Clinic for treatment while they awaited the arrival of MFD. Upon arrival at the Medical Clinic, they realized the wheel chair was too large to fit through the doorway. Lt. Haw then retrieved a chair and Wilson was transferred from the wheelchair to that chair and placed in the waiting area of the clinic. Lt. Haw stated that they realized that Wilson had become unresponsive. Staff then confirmed that Wilson was not breathing and did not have a pulse. Wilson was then placed on the floor and staff, along with RN Markwardt began CPR and attempted to utilize the AED, but the AED gave a "No

Shock advised" response. At 2218 Hours the MFD arrived and took over resuscitation efforts. At 2255 hours the MFD declared Wilson deceased and ceased all resuscitation efforts. Lt. Haw stated that Wilson appeared "out of it" during the transport to the clinic but he did over hear Wilson say "Help or Help me" during that time. Lt. Haw stated that he did not have any contact with Wilson prior to this incident and was unaware of the reason for the original call for a medical emergency. Lt. Haw also stated that he did not have concerns with how staff responded or any of the treatment issued to Wilson. This concludes the summary of the interview with Lt. Steven Haw.

Summary of Interview with RN Samantha Markwardt RN Samantha Markwardt was interviewed next and was interviewed in the Jail Administration Conference room located at the Milwaukee County Jail on the morning of 08/30/17. The interview was recorded with RN Markwardt's permission. RN Markwardt is employed with Armor Correctional, who is contracted by Milwaukee County to provide medical care at the MCJ. RN Markwardt is a nursing supervisor and is assigned to the 1800-0600 hours shift. RN Markwardt stated that she had learned that Wilson had gone through the pre-booking process, which is where a determination is made as to whether or not accept an inmate or decline entry to the jail after conducting a brief review of the arrest and health summary of the individual being brought to the jail. If the individual is cleared from the pre-booking process and initial medical assessment, they are then accepted entry to the jail where they then complete the full booking process. Wilson was cleared from the pre-booking process and was accepted to complete the remainder of the booking process on the morning of 08/29/17 and did not indicate any health issues at the time. RN Markwardt later stated that staff is familiar with Wilson, since he has in the past, provided Jail Medical different information during medical screening at the jail. One example provided showed that during one incarceration and medical screening, Wilson informed staff he was and at a later incarceration and medical screening he denied being and at a later incarceration and medical screening he denied being and at a later incarceration and medical any contact with Wilson on 08/29/17 until she responded to the medical emergency call made by C.O. Jackson. RN Markwardt arrived in Pod 3B and awaited the arrival of other Officers before the cell door was opened. RN Markwardt believed Wilson was leaning on the door because he appeared to stumble out of the cell when the door was opened. Wilson informed her that he "felt like he was dying" and appeared to have difficulty breathing. Wilson informed RN Markwardt that he has asthma but RN Markwardt was aware that Wilson had never reported that before. RN Markwardt was able to obtain a pulse-ox level from Wilson which was 72%. After obtaining the reading, RN Markwardt went to the Officer's station and immediately contacted the On Call Nurse Practitioner per protocol. RN Markwardt was advised to immediately begin a breathing treatment on Wilson and have him transported to a local hospital for further treatment. RN Markwardt then instructed Lt. Haw to call for an ambulance to have Wilson transported and also to retrieve a wheelchair. RN Markwardt observed as staff carried Wilson down from the upper tier to the lower tier and into a wheelchair and eventually to the doors leading to the Medical Clinic. RN Markwardt felt the MCSO staff was very professional and went to extreme measures in the initial care for Wilson and acted in a safe manner when carrying him down the stairs from the upper to the lower tier. Upon arriving at the clinic, RN Markwardt began preparing for the breathing treatment when she was advised by MCSO staff that Wilson was now unresponsive and possibly pulseless and non-breathing (PNB). RN Markwardt came over and

confirmed that Wilson was PNB and was assisted by MCSO staff in lowering Wilson to the floor. RN Markwardt immediately began CPR with the assistance of MCSO staff until the MFD arrived a short time later. RN Markwardt also acknowledged that there was an attempt to use a jail AED but "no shock advised" was the response or prompt staff received.

RN Markwardt did not have any contact with Wilson on 08/29/17 prior to the medical emergency call and was not aware of any medical concerns that Wilson had prior to the call as well. RN Markwardt was highly appreciative of the actions taken by MCSO staff and praised their response during the call. It should be noted that RN Markwardts actions were confirmed via video surveillance along with confirmation of the call she placed to the On Call Nurse Practitioner. This concludes the summary of the interview with RN Markwardt.

Summary of Interview with Correctional Officer Yoshiette Hamilton C.O. Hamilton was interviewed next. The interview was conducted in the Jail Administration Conference room located at the Milwaukee County Jail on the morning of 08/30/17. The interview was recorded with permission from C.O. Hamilton. C.O. Hamilton stated that she was working second shift on 08/29/17 and was assigned to Pod 6B and had completed her final inspection of night when she overheard the medical emergency call made by C.O. Jackson. C.O. Hamilton stated she responded and stood by in case someone need to be "tapped out", she described this as taking over for someone who is tired or needs to be relieved. C.O. Hamilton later relieved C.O. McBroom and held down Wilson's right arm. During this time C.O. Hamilton stated she overheard Wilson make comments referencing his "legs hurting" and he "felt like he was going to die". C.O. Hamilton was "tapped out" a few minutes later and continued to observe while staff treated Wilson. C.O. Hamilton cleared from this incident once Wilson was taken from Pod 3B. This concludes the summary of the interview with C.O. Hamilton.

Summary of interview with Lieutenant Michael Stevens
The interview was conducted in the Jail Administration Conference room and was
not recorded. Lt. Stevens stated he was assigned to second shift on 08/29/17
and was in the Operations Office working on paperwork when the original
emergency call was made. A short time later Lt. Stevens overheard a radio call
for "MFD to step it up". Lt. Stevens then looked on surveillance camera and
observed staff performing CPR on an inmate. Lt. Stevens responded to assist
with chest compressions before being relieved. Lt. Stevens had no further
involvement in this incident. This concludes the summary of the interview with
Lt. Stevens.

Summary of interview with Lieutenant Julie Shanahan
Lt. Shanahan stated that she responded to the Medical clinic after hearing a
request for additional staff to respond. Upon arrival Lt. Shanahan completed
administrative duties, which consisted of gathering the appropriate paperwork
for an inmate being transported to the hospital, organizing staff to assist with
CPR, meeting and escorting the MFD, and had no "hands on" involvement in
Wilson's care. This concludes the summary of the interview with Lt. Shanahan.

Summary of interview with Correctional Officer Cory Jensen
The interview took place in the Jail Administration conference room and was
recorded. C.O. Jensen stated he is assigned to second shift and was working in
the booking area on 08/29/17. C.O. Jensen responded to the original emergency
call in Pod 3B and upon arrival assisted in securing Wilson's legs during the

initial assessment. C.O. Jensen then assisted in carrying Wilson down the stairs from the upper tier to the lower tier. C.O. Jensen held Wilson's legs during this time. Once they arrived in the clinic it was determined that Wilson was PNB and C.O. Jensen then assisted in performing CPR until the MFD arrived on scene. C.O. Jensen had no further involvement in this incident. This concludes the summary of the interview with C.O. Jensen.

Summary of interview with Correctional Officer Trevor Trello
The interview took place in the Jail Administration conference room and was
recorded. C.O. Trello stated he was assigned to second shift 5th floor control
on 08/29/17. C.O. Trello stated he had no hands on involvement in the incident
but while observing on security surveillance cameras, did witness treatment
being provided to Wilson. C.O. Trello then responded in case his assistance was
needed and escorted staff as they transported Wilson to the Medical Clinic.
C.O. Trello remained on scene while staff performed CPR in case he was needed to
assist but was cleared a short time later. C.O. Trello had no further
involvement or knowledge of this incident. This concludes the summary of the
interview with C.O. Trello.

Summary of interview with Correctional Officer Kiarri McBroom
The interview took place in the Jail Administration conference room and was recorded. C.O. McBroom stated that he was assigned to second shift and was assigned to Pod 3A on 08/29/17. Upon hearing the original call for a medical emergency he retrieved an AED and oxygen and responded to Pod 3B. C.O. McBroom assisted in securing Wilson's arm since he was making violent movements. C.O. McBroom heard Wilson state he "couldn't breathe and was dying" and also that his (Wilson's) "legs hurt". C.O. McBroom assisted in transporting Wilson to the clinic and once they arrived in the clinic it appeared that Wilson was "losing life" according to C.O. McBroom. Staff then confirmed that Wilson was PNB and began performing CPR. C.O. McBroom assisted in performing chest compressions until he was later relieved. C.O. McBroom stated he was "emotionally shook up" and cleared form the incident after being relieved. C.O. McBroom had no further involvement in the incident. This concludes the summary of the interview with C.O. McBroom.

Summary of interview with Correctional Officer Michael Saporito
The interview took place in the Jail Administration conference room and was recorded. C.O. Saporito was assigned to observed inmate workers during his assigned shift on 08/29/17. C.O. Saporito responded to the original emergency call in Pod 3B and upon arrival assisted in securing Wilson's legs during the initial assessment. C.O. Saporito then assisted with placing a RIP belt on Wilson and observing staff before clearing the incident as Wilson was being transported to the clinic. C.O. Saporito did recall hearing Wilson state his "legs hurt". C.O. Saporito had no further involvement in this incident. This concludes the summary of the interview with C.O. Saporito.

Summary of interview with Correctional Officer Gregory Walker
The interview took place in the Jail Administration conference room and was
recorded. C.O. Walker was assigned to the 4th floor Movement Officer position
during his assigned shift on 08/29/17. C.O. Walker responded to the original
emergency call in Pod 3B and upon arrival assisted in securing Wilson's hands
utilizing the RIP belt. C.O. Walker recalls hearing Wilson yell "oh my legs".
Prior to transporting Wilson to the Medical clinic, C.O. Walker retrieved a wash
cloth from Wilson's cell and soaked it with cool water and placed it on Wilson's

head and neck area in an attempt to cool him down. During the transport to the Medical clinic Wilson flinched and upon arrival in the clinic Wilson appeared to go unresponsive. Once the RN confirmed Wilson was PNB, C.O. Walker assisted with CPR. This concludes the summary of the interview with C.O. Walker.

Summary of interview with Correctional Officer Rebecca Ehrman
The interview took place in the Jail Administration conference room and was
recorded. C.O. Ehrman was assigned to the position of Female Changeover Officer
during her assigned shift on 08/29/17. C.O. Ehrman responded to the original
medical emergency call and recalls Wilson "thrashing around" after exiting his
cell. C.O. Ehrman recalls Wilson's behavior as bizarre and assisted in securing
Wilson's left hand while the RN was attempting to check on Wilson. During the
transport to the Medical Clinic she heard what she described as noisy breathing
coming from Wilson. Once they arrived in the clinic it was determined that
Wilson was PNB and C.O. Ehrman then assisted in performing CPR until the MFD
arrived on scene. C.O. Ehrman had no further involvement in this incident.
This concludes the summary of the interview with C.O. Ehrman.

Summary of interview with Correctional Officer Anthony Emanule
The interview took place in the Jail Administration conference room and was
recorded. C.O. Emanuele was involved in the booking process on Wilson on the
morning of 08/29/17 and recalled Wilson as being sore which Wilson verbally
informed him of while dressing Wilson in. C.O. Emanuele had no further
information for the Detective. This concludes the summary of the interview with
C.O. Emanuele.

Summary of interview with Correctional Officer Jacquise Payne C.O. Payne stated he assisted in removing the RIP Belt from around Wilson's waist and also held an I.V. bag while the MFD continued CPR. C.O. Payne had no other involvement in this incident. This concludes the summary of the interview with C.O. Payne.

Summary of interview with Correctional Officer Andrew Hynst C.O. Hynst stated that he was assigned to Pod 4D during his assigned shift on 08/29/17. C.O. Hynst stated staff were informed to stand by in roll call after their assigned shifts in case they were needed to assist with the medical emergency. At 2230 hours Lt. Shanahan requested additional Officers respond to the clinic. C.O. Hynst responded and completed 4 rounds of chest compressions before he was relieved. C.O. Hynst remained on scene until the MFD declared Wilson deceased. This concludes the summary of the interview with C.O. Hynst.

Summary of interview with Correctional Officer Samantha Taylor The interview was conducted in the Jail Administration Conference room and was not recorded. C.O. Taylor stated that she was assigned to the Mental Health Unit on the 2nd floor of the MCJ on 2nd shift on 08/29/17. C.O. Taylor stated that Lt. Shanahan had requested that staff stand by in roll call in case they were needed to assist with the medical emergency. At 2235 hours, a request for additional Officers was made and C.O. Taylor responded. C.O. Taylor stated that staff was lined up to assist with performing chest compressions on an inmate. C.O. Taylor stated that she performed 2 sets of compressions on the inmate. C.O. Taylor took no further action in this incident. This concludes the

summary of the interview with C.O. Taylor.

Summary of interview with Correctional Officer Amika Avery
The interview was conducted in the Jail Administration Conference room and was
not recorded. C.O. Avery stated that she was assigned to position of
Break/Movement Officer on second shift on 08/29/17. C.O. Avery stated that she
did not hear the original emergency call but later learned of the incident from
other Corrections Officers and responded to the clinic but was informed they had
enough staff on scene. A short time later C.O. Avery heard a radio call
requesting additional Officers to the Medical clinic and responded. C.O. Avery
stated that upon arrival she performed 70 chest compressions on the inmate
before she became emotional and had to be relieved. Once relieved, C.O. Avery
cleared from the incident. C.O. Avery had no other involvement in this
incident. This concludes the summary of the interview with C.O. Avery.

Summary of interview with Correctional Officer LaCinda Sloan
The interview was conducted in the Jail Administration Conference room and was
not recorded. C.O. Sloan stated that she was assigned to Pod 3D on second shift
on 08/29/17. C.O. Sloan observed staff transporting Wilson to the Medical
Clinic, but never heard the emergency call. C.O. Sloan responded to the Medical
Clinic and observed staff enter the clinic and heard someone say call 911 and
start CPR. C.O. Sloan remained on scene for a short time before clearing
without taking any action. This concludes the summary of the interview with C.O.
Sloan.

Summary of interview with Correctional Officer Patrice Wright-Perry The interview was conducted in an attorney cubicle located on the 6th floor of the jail and was not recorded. C.O. Wright Perry stated she was assigned to Pod 5D on second shift on 08/29/17. C.O. Wright-Perry did respond to a call for assistance requesting additional Officers in the Medical Clinic. Upon arrival she observed staff performing CPR on an inmate and was instructed to clear from the area. C.O. Wright-Perry had no further involvement in this incident. This concludes the summary of the interview with C.O. Wright-Perry. Summary of interview with Correctional Officer Devin O'Donnell C.O. O'Donnell stated that he was assigned to Pod 4B on second shift on 08/29/17. C.O. O'Donnell stated that upon hearing that an inmate was being transported to the hospital he retrieved a "hospital run kit" and responded to the sally port. C.O. O'Donnell then heard a radio call requesting additional Officer's respond to the Medical Clinic. C.O. O'Donnell responded and completed "2 or 3" rotations of CPR. C.O. O'Donnell had no further involvement in this incident. This concludes the summary of the interview with C.O. O'Donnell.

Summary of interview with Correctional Officer Brian Wenzel C.O. Wenzel stated that he was working overtime in Photo ID on second shift on 08/29/17. C.O. Wenzel responded to a request for additional staff to respond to the Medical Clinic and upon arrival completed "2 rounds of 60 compressions" of CPR before clearing. C.O. Wenzel had no further involvement in this incident. This concludes the summary of the interview with C.O. Wenzel.

Summary of interview with Correctional Officer Dashyla Elliott C.O. Elliott was assigned to third shift Jail records on 08/29/17. C.O. Elliott responded to the Medical Clinic after hear a request for additional Officers to respond. Upon arrival, C.O. Elliott assisted with conducting 1 round of 60 chest compressions and cleared from the incident. C.O. Elliott had no further

Summary of interview with Correctional Officer Shondel Thompson C.O. Thompson stated that she was assigned to 3rd floor control on second shift on 08/29/17. C.O. Thompson stated that C.O. Jackson exited her pod and was completing paperwork and was out of her pod for "10-20 minutes, maybe 30" but wasn't sure. C.O. Thompson did not recall having control of C.O. Jacksons pod when she exited out of it, but did go over the security procedure of transferring control of a pod with Det. Donner. C.O. Thompson did not have any hands on involvement or further knowledge of this incident. This concludes the summary of the interview with C.O. Thompson.

Summary of interview with Correctional Officer Matthew McCoy C.O. McCoy was working overtime on second shift in a Movement position on 08/29/17 when he heard the emergency call in Pod 3B. C.O. McCoy arrived but when asked if he had been "working for 16 hours" by Lt. Haw, he replied he had and was directed to clear by Lt. Haw. C.O. McCoy had no further involvement in this incident. This concludes the summary of the interview with C.O. McCoy.

Summary of interview with RN Sheba Lopez

RN Lopez stated that she was assigned to the Booking area on the evening of 08/29/17 when she heard about the incident. RN Lopez proceeded to the Medical Clinic and observed the MFD working on an inmate. RN Lopez stated that she spoke with RN Markwardt and began ensuring that the appropriate protocols were being completed and took no action in Wilson's care. This concludes the summary of the interview with RN Lopez.

Summary of Interview with Correctional Officer Benjamin Giese On 09/19/17, Detective Hoppe and Detective Wepfer interviewed C.O. Giese in an attempt to clarify the statements made by two inmates that Wilson was suffering from medical issues on his shift, 0600-1430 on 08/29/17. The interview was conducted in the Jail Administration Conference room located at the Milwaukee County Jail. The interview was recorded with permission from C.O. Giese. C.O. Giese went over his routine for a regular shift in a pod and afterwards was asked if he remembered anything about the events on 08/29/17 or if he remembered Clarence Wilson. C.O. Giese stated that he did not remember Wilson, and did not recall anything specific or out of the ordinary on that day. When asked if he remembered having any medical emergency or other significant issues in a pod, C.O. Giese referenced having medical emergency several weeks prior in Pod 4C. C.O. Giese went over his guidelines for calling any emergency and stated that chest pain or trouble breathing would be cause for an immediate medical emergency. I then asked C.O. Giese if he had any problems in the pod on 08/29/17 since two inmates alleged that Wilson had fallen down and got taken out of the pod, C.O. Giese stated that he never had any issues that he could recall and his activity log, and surveillance video appear to confirm that information as well. Arrest

On 08/28/17 at 2031 hours, Probation and Parole Agents Christy Mueller and Heather Reihl-Vogel responded to 2642 N 9th Street in the City of Milwaukee in an attempt to conduct a house check on Clarence Wilson. Reihl-Vogel and Mueller are assigned to the Repeat Offender Prevention Enforcement (ROPE) Unit. City of Milwaukee Police Officer Artavious Bradford was assigned to assist them in conducting checks throughout the evening. Upon arriving at Wilson's residence, a urine sample was obtained from Wilson which subsequently tested positive for cocaine. Wilson was then taken into custody by Officer Bradford at 2046 hours. After being handcuffed, Wilson became highly agitated and was slightly resistive while awaiting a conveyance van to arrive. Officer Bradford then used his radio to transmit to dispatch asking for "whoever is coming to step it up", effectively requesting the conveyance van to respond as soon as possible. Officer Bradford used a minimal amount of force during this encounter and held Wilson against a wall until Wilson calmed down and was eventually placed on the ground where he was still very argumentative but was not physically resistive. During this time Wilson complained of arm pain related to the arrest and Officer Bradford asked Wilson if he needed medical attention. Wilson replied "yes" and Officer Bradford contacted dispatch and requested EMS respond for Wilson's complaint of arm pain.

EMS assessment and transport for medical clearance At 2105 hours Curtis EMS responded and while conducting their initial assessment. Officer Bradford informed Curtis EMS personnel, Jeanette Volcensek and Wayne Stainbrook, that Wilson had tested positive for cocaine and was slightly resistive after being handcuffed. EMS felt that Wilson's "alertness level" had diminished during their initial assessment and based on the alleged cocaine use, per protocol, they issued Narcan for precautionary measures. Wilson never lost consciousness during the incident according to the parties involved, though it was documented that Wilson was verbally argumentative and non-cooperative with EMS as well. Neither Volcensek nor Stainbrook had any concerns about the situation and later transported Wilson to Columbia St. Mary's Hospital per his request to be treated at a local hospital, where they arrived at 2149 hours. During the transport, Milwaukee Police Officer Lamar Lucky rode in the ambulance with Wilson, while Milwaukee Police Officer Brian Flannery followed in the conveyance van. It should be noted Officers Flannery and Lucky had arrived prior to EMS arriving on scene. After EMS cleared Officer Bradford completed his assignment with Probation and Parole and cleared from the incident, with Officer Flannery agreeing to complete the booking process of Wilson and transport to the Milwaukee County jail after being medically cleared. Wilson was medically cleared from Columbia St. Mary's at 0025 hours on 08/29/17 and later transported to the Milwaukee Police Department District #3, where they arrived at 0056 hours, for the booking process by Officers Flannery and Lucky. After completion of the booking process Officers Flannery and Lucky transported Wilson to the Milwaukee County Jail and turned Wilson over to jail staff without incident.

Surveillance footage

While reviewing the arrest, medical clearance, booking process, and transport to the Milwaukee County jail surveillance video of the following cameras were reviewed:

- * Officer Bradford's body camera
- * Milwaukee Police Department District #3 Sally port
- * District #3 Fingerprint room
- * District #3 Booking area
- * District #3 Adult Cells holding area

While reviewing the arrest video and conducting interviews with the parties involved, it clearly shows that Wilson was argumentative with Probation and Parole and was placed into handcuffs, with his hands behind his back. At one point Wilson attempts to jerk away from Officer Bradford and Officer Bradford places Wilson against a wall in an attempt to control Wilson. Officer Bradford is calm and in control of the situation but does ask for the conveyance van to "step it up" due to Wilson's behavior. Wilson is continually heard stating "fuck me up" to Officer Bradford. The video does show Officer's Flannery and Lucky arriving along with EMS and shows the interaction between all parties on scene. At no time is there any force used against Wilson and it clearly shows the Officers attempting to calm Wilson down. It should be noted that Officers Flannery and Lucky had just begun their shift and heard Officer Bradford call for them to "step it up" and therefore did not have enough time to set up up their Department issued body cameras, Officer Flannery indicated that the battery for his camera had not charged overnight as well. It was also noted that Officer Flannery stated that while their conveyance van had a squad mounted camera, it was not functioning properly, due to a lack of an internet connection. Officer Flannery stated that this is an ongoing issue. Officer Flannery stated that nothing of significance occurred at the hospital during medical clearance. Upon arriving at District #3, surveillance video shows the conveyance van arriving in the sally port and Wilson being escorted into the facility. The surveillance video at District #3 has audio and while Wilson is there, all of his movements are recorded and later documented in the timeline in the report. There is nothing noteworthy noted during the review. The video does end with the conveyance van exiting the sally port.

Interview of roommates of Wilson

Citizen Witnesses Anthony Prather (interviewed by WKSO Detectives Kohl and Herrmann on 08/31/17 at 2644 N 9th Street) and Kyle Haggerty (interviewed by WKSO Detective Seitz on 08/30/17 at 2644 N 9th Street) were later interviewed in regards to the arrest of Wilson. Prather stated that he was also tested by Probation and Parole along with Haggerty prior to Wilson being tested. Prather stated at some point he observed the conveyance van arrive and shortly after, an ambulance. Prather went on to state that he later observed Wilson being

escorted from the residence in handcuffs and led to the ambulance. Prather did not hear any arguing or fighting prior to Wilson being escorted to the ambulance and it appeared to him that Wilson was being cooperative while being escorted. Prather denies ever seeing Wilson interacting with Probation and Parole on the evening of 08/28/17. Haggerty provided the same information while being interviewed except for adding that Wilson was walking with his usual limp or gait while being escorted, but again that is normal for Wilson. Neither party had any information directly related to the arrest of Wilson since they were in a separate area of the residence at the time.

Medical Clearance at Columbia St. Mary's Hospital
Medical records obtained from Columbia St. Mary's Hospital by Detective Hoppe
via subpoena state Wilson presented with "LUE", which is Left Upper Extremity,
pain. Patient states he sustained the injury within the last hour due to
twisting when he was placed into custody. Wilson informed medical staff that
the pain was a 5 on a scale of 1-10 and the pain was from his wrist to his
shoulder. Wilson also confirmed with staff that he had smoked crack cocaine
earlier in the evening. Wilson was given minimal treatment and could not
provide a urine sample to staff during his time at the hospital and also
admitted that he had not been taking his insulin since he had been released from
custody. Wilson was discharged in stable condition according to the discharge
summary and with instructions on properly taking his prescribed medication.

Summary of the review of Wilson at the MCJ Upon conducting the review of Wilson's incarceration at the MCJ the following surveillance video was obtained and reviewed Detective O'Toole:

During the review of the surveillance footage obtained from the MCJ, Wilson is shown arriving in the sally port at 0200 hours and going to the pre-booking and search area. There is nothing significant noted during this period and Wilson is showing to be interacting and does appear to be cooperative between 0204 hours and 0240 hours while he is in the pre-booking area. Wilson is then observed in the booking area at 0424 hours where his is observed interacting with other individuals and eventually transported to Pod 3B for housing on the morning 08/29/17. Wilson is observed interacting with inmates and moving around in the pod and retrieving dinner. Wilson does have a noticeable limp but does not appear to be in any distress. Wilson does not have any issues during the lockdowns throughout the day and evening and does not make any phone calls which was confirmed through jail inmate phone records. Wilson is observed locking in for the evening and there is no other activity until C.O. Jackson is observed entering the pod and going to Wilson's cell which is out of camera view at this point. A short time later, the camera is panned towards Wilson's cell and the door to the cell is opened a short time later. Wilson appears to stumble out of his cell and lands on the floor in front of his cell where he is then tended by Correctional staff as well as the nurse.

Jail calls

Recordings of jail calls from pod 3B were obtained and later reviewed by Detectives Hoppe and O'Toole. It was determined through the Inmate calling system that Wilson did not make any calls while he was incarcerated. While reviewing the calls made by inmates in Pod 3B on 08/29/17, very few inmates discuss the matter. The inmate in Cell #42, identified as Terrell Hall, initially told Detectives he did not "see or hear anything" is overheard talking about being traumatized and "expects to be paid". There is another conversation in which inmate Marcus Newsome, assigned to cell #36, talks about contacting the media because "the CO's didn't do nothing" to help Wilson which is clearly false information. The remainder of the calls are consistent with the information learned through the investigation and are not noteworthy.

Autopsy and Cause of Death

On 08/30/17 Detective Christopher Kohl attended the autopsy of Clarence Wilson which was conducted at the Milwaukee County Medical Examiner's Office. The preliminary cause of death was natural and related to heart disease. A final report was conducted by the M.E.'s Office on 09/05/17 with the following ruling noted:

Cause of Death: Acute Coronary artery thrombosis due to

Other significant condition: Hypertension

Manner of Death: Natural

There was also a toxicology report that indicated there were metabolites for cocaine in Wilson's urine and blood which are indicative of cocaine use.

Relative Notification

* Alan T. Tallies- Uncle of Clarence Wilson

On the morning of 08/30/17, Detective Jensen and Detective Hoppe did meet with Alan Tallies at his residence located at 3226 N 33rd Street in the City of Milwaukee. Upon making contact with Tallies, we confirmed his relationship with Wilson and informed Tallies that Wilson had been taken into custody on 08/28/17 and had a medical emergency while incarcerated at the Milwaukee County Jail. It was further explained to Tallies that medical attention was given but Wilson had passed away. Tallies stated that he was unaware that Wilson had been incarcerated and seemed surprised since he had just been released from custody on 08/18/17. Tallies stated that he wasn't surprised at Wilson's passing and said "it was probably because of his drug use". Tallies went to state that Wilson was a

According to Tallies, Wilson would go weeks without taking his prescribed medication even though he had the opportunity to obtain them. Tallies identified Wilson's drug use as using marijuana and crack cocaine. Tallies stated that Wilson has no other family or friends in the surrounding area and he (Tallies) is the closest relative that Wilson had. Tallies appeared to be emotional but cooperative and stated he had no doubt Wilson's passing was related to his drug use. Contact information was provided to Tallies before ending the interview.

Milwaukee County Jail AED Download

The AED that was used by Correctional Staff was collected as evidence on the morning of 08/30/17. On 09/05/17 the AED was removed from Property Inventory by Captain Patrick Esser and Detective Hoppe. The AED was then taken to the Milwaukee County EMS Offices by Detective Hoppe and Detective Herrmann in an attempt to download the recordings that were captured during the attempted resuscitation efforts of Wilson by Correctional Staff on 08/29/17. The AED was downloaded by EMS Coordinator Marty Rukavina.

Afterwards the AED was returned to Property Inventory and the results of the download are as follows:

Summary of re-Interview of Correctional Officer Cristal Jackson On 09/27/17 Detective Hoppe and Detective O'Toole did conduct a brief follow-up interview with C.O. Cristal Jackson at the Milwaukee County Jail. The interview was recorded with C.O. Jackson's permission and was conducted in a Conference room of the Milwaukee County Sheriff's Department administration area. During the interview C.O. Jackson was asked if she recalled anything since the first time we had talked on the morning of 08/30/17. C.O. Jackson stated that she has been thinking about the incident but did not have any new information to provide. C.O. Jackson then gave a brief description of the events that occurred that evening. I then informed C.O. Jackson that I wanted to clarify why she had not transferred over control of her Pod to Floor Control when she exited. C.O. Jackson admitted that she was very frustrated and felt rushed when the nurse came into her pod after she had locked the pod down for the evening. C.O. Jackson voiced her concerns for being a new C.O. and wanted to turn her paperwork in on time as to not upset her bosses. C.O. Jackson became even more frustrated when she received 5 new inmates at 2115 hours. After securing them in their appropriate housing, C.O. Jackson was in a rush and inadvertently exited the pod without turning over control of her pod to Floor Control. C.O. Jackson appeared to very remorseful and stated that at no time was she made aware of any inmate in distress prior to exiting her pod. C.O. Jackson completed her paperwork and spoke with Officers outside of the pod prior to entering her pod again at 2155. C.O. Jackson then repeated the version of events she had supplied during her first interview. C.O. Jackson seemed very nervous about the situation and was very apologetic during the interview. After the recording had been shut off, C.O. Jackson continued to voice her concerns for the family of Wilson. This concludes the summary of the re-interview with C.O. Jackson.

Training records of Correctional Officer Cristal Jackson
Detective Hoppe did retrieve C.O. Jackson's training records and evaluations
during her training as a Corrections Officer. After reviewing the files, they
do indicate that there are deficiencies that need improvement, such as;
monitoring inmates, updating activity log, and officer safety. The notations in
regards to security logs are relevant since C.O. Jackson admitted that she did
not document the nurse exiting the Pod on the evening of 08/28/17. There are no
notations or evidence documenting any issues with computer programs which

control the pod security system. This would indicate that C.O. Jackson was trained and aware of the proper procedure.

Facts and Summary of the investigation
On 08/28/17 Clarence Wilson was arrested at his residence after failing a
mandatory drug screen through Probation and Parole. Wilson was taken into
custody by Officers from the Milwaukee Police Department, during the arrest
Wilson was argumentative and later complained of a sore shoulder and arm due to
attempting to jerk away from the Officer's grasp. EMS was called at the request
of Wilson, and responded. While EMS was evaluating, Wilson became lethargic
according to Curtis EMS personnel and was given narcan per their protocol, due
to his suspected drug (cocaine) use. Wilson then requested to be seen at a
hospital for his arm pain and was subsequently transported to Columbia St.
Mary's Hospital for further treatment.

After being medically cleared from Columbia St. Mary's Hospital, Wilson was transported to Milwaukee Police Department District #3 for booking purposes. Upon completion of the booking process Wilson was transported to the Milwaukee County Jail where Wilson was turned over to jail staff. Wilson was then assigned to Pod 3B of the Milwaukee County Jail and placed into cell #43. Wilson does not appear to be in any distress and did not advise nursing staff of any health concerns upon his arrival to the jail on 08/29/17. Wilson spent the second half of dayshift in the Pod and was interacting with others and had lunch. Wilson also interacted and had dinner during second shift and neither C.O. Giese nor C.O. Jackson reported any concerns or behavioral issues with Wilson during the shifts on 08/29/17. Wilson's pod was locked in for the evening on 08/29/17 at 2059 hours. The nurse entered the pod at 2100 hours and conducted a medication pass. At 2115 hours 5 new inmates were assigned to the pod and were placed into their assigned cells and entered into the system. C.O. Jackson exited the pod at 2126 hours. At this point, per policy and procedure, C.O. Jackson should have transferred over control over her pod to Floor Control. The purpose of completing this action is to ensure that in case there is an emergency in the pod or an inmate has an emergency, Floor Control would be able to answer any emergency intercom calls. C.O. Jackson exited her pod without turning over control, which simply consists of her signing out of her Officer Station terminal. This information was later confirmed with the Floor Control Officer. C.O. Jackson returned to her pod at 2156 hours and was immediately notified by inmates that cell #43 was in trouble. C.O. Jackson immediately responded to Wilson's cell and he advised her that he was having trouble breathing and C.O. Jackson called for a medical emergency. As C.O. Jackson returned to her Officer Station to let other officers in the pod, she realized that her computer screen was "lit up" with inmate's emergency intercom alarms, indicating that inmates had activated their emergency alarms in an attempt to notify staff of the problems. When asked how many had activated their alarms, C.O. Jackson stated "pretty much all of them". That is when C.O. Jackson realized she had not turned over control of the pod to floor control. C.O. Jackson was very honest about not turning over control. Based on statements and video that was obtained, there is nothing to suggest that C.O. Jackson was aware of any distress that Wilson may have been in prior to her exiting the pod. In addition, based on the statements of the pod inmates, which are very consistent, it appears that Wilson does not start suffering from his medical condition until after C.O. Jackson exited the pod.

Once MCSO and medical staff were on scene, Wilson was treated and immediately

transported to the medical clinic for further treatment with the expectation to transport him to a hospital for advanced treatment. There did not appear to be any delay in treatment for Wilson after MCSO staff were made aware of Wilson's medical emergency. The time from the original medical emergency call, made by C.O. Jackson, to the MFD arriving on scene was 19 minutes. Staff did not hesitate to start CPR when it was determined that Wilson was PNB, and staff attempted to use an AED during this time. An autopsy revealed that Wilson's death was natural and related to heart disease.

There is no evidence of foul play and the only concern would be the fact that even though C.O. Jackson knew she should have turned over control of her pod to Floor Control, she did not. There is nothing to suggest that this was an intentional act, as it appears that Wilson was not showing any signs of distress prior to C.O. Jackson leaving the pod and C.O. Jackson admits she was in a rush near the end of her shift. If C.O. Jackson had in fact turned over control of her pod as trained, it more than likely would have meant a more timely response to the activation of emergency intercom calls. I am asking for the case to be reviewed by the Milwaukee County District Attorney's Office to determine if this incident would meet the necessary requirements for C.O. Jackson to be charged with a criminal violation of the Wisconsin State Statues.
