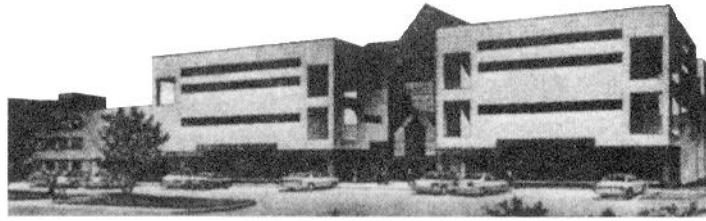

Search Warrants – Village of Menomonee Falls

On Tuesday, March 30th, 2021, the Waukesha County Sheriff's Department executed a search warrant at Superstar Buds, N88W16733 Main Street. Superstars Buds is self-described on the businesses' website and store signage as a CBD dispensary.

The Sheriff's Department began investigating the business after becoming aware of a non-fatal overdose incident involving two small children whom unintentionally ingested a CBD-related product. In the incident, the suspected product was obtained by the children's parent from Superstar Buds.

During the investigation leading up to this search warrant, investigators obtained evidence that the business was selling products containing prohibited levels of delta-9-tetrahydrocannabinol (THC). These products were labeled by the business as CBD or delta-8-THC.

Wisconsin state law allows for the sale of CBD related products; however, CBD related products are permitted to have a delta-9-THC content of not more than .3%. Several of the products that were obtained from Superstar Buds during this investigation were found to have delta-9-THC levels in excess of 20%.

During the execution of this search warrant, investigators seized numerous additional products from the business that were labeled as CBD or delta-8-THC that are believed to contain prohibited amounts of delta-9-THC. Three individuals were arrested at the business in relation to this search warrant and charges will be presented to the Waukesha County District Attorney's Office at a future date.

It should be noted that Superstar Buds is located in close proximity to Menomonee Falls North Middle School, which is located at N88W16801 Main St., Menomonee Falls.
