

Farmers' Market Wireless EBT (Electronic Benefits Transfer) Program

Kev Cog Lus Koom Tes ntawm Cov Ua Teb thiab Cov Muag Khoom

Thaum muab cov nyiaj ntawv muas noj hloov mus rau cov electronic debit cards, cov neeg ua teb thiab cov ua lag luam uas yeej muag khoom tom khw tshav puam tsis muaj peev xwm txais tau cov nyiaj muas noj lawm. Txawm hais tias yeej muaj cov tshuab luam cov nyiaj muas noj FoodShare uas yog point of sales (POS) units (Wisconsin cov nyiaj muas noj) yam li tsis muaj nqi tes rau cov neeg ua lag luam uas muaj feem tau, los cov tshuab no yuav tsum muaj fais fab thiab xaim xov tooj thiaj siv tau. Yog li no cov khw tshav puam thiaj siv tsi tau cov tshuab no. Vim hais tias qhov POS unit cov xaim xov tooj ua tsis cab hlua thiab kev tswj txoj kev pab cuam no yuav raug nqi rau cov khw tshav puam, thiaj li muaj kev tshawb nug no los ntsuam xyuas seb puas yuav pab coj tau neeg tuaj yuav khoom kom coob ntxiv yog muaj kev txais tau cov nyiaj muas noj. Txoj kev tshawb nug no, uas yog lub University of Wisconsin Cooperative Extension nyob Waukesha County, yuav muab kev ntsuam txog kam noj kev haus thiab seb puas tsim nyog nrhiav kev pab rau kaum lub khw tshav puam hauv Wisconsin kom siv tau EBT nyob hauv cheeb tsam uas muaj neeg feem coob tau FoodShare. Kev tshawb nug no yog tau nyiaj los ntawm United State Department of Agriculture Farmers' Market Promotion Program.

Kev Koom Tes

Kuv yog ib tug muag khoom nyob rau hauv lub khw tshav puam uas siv qhov wireless "market terminal" rau cov khoom uas muaj feem hauv FoodShare/EBT thiab xav muab kev koom tes rau txoj kev tshawb nug no thiab xav txais cov EBT tokens. Kuv to taub hais tias ntawm kev koom tes no, kuv yuav tsum ua daim ntawv cog lus kom tiav thiab kos npe rau. Kuv to taub hais tias lub khw tus program manager yuav muab kev pab ntxiv nyiaj rau kuv kom puv li tus nqi ntawm lub token uas kuv txais uas muaj lub khw tshav puam lub npe teev rau. Kuv kuj to taub hais tias kuv yuav tau ib daim paib sau hais tias "We gladly Accept EBT Tokens" kom cov neeg tuaj kav khw thiaj paub hais tias kuv yog ib tug tswv muag khoom uas koom tes txais cov nyiaj muas noj thiab.

Kuv to taub hais tias lub khw yeej pom zoo muab kev koom tes nrog lub University of Wisconsin Cooperative Extension muab kev tshawb kawm txog kam noj kev haus thiab qhov zoo ntawm tej zaub mov uas siv EBT hauv lub khw tshav puam. Kuv to taub hais tias raws li lub khw kev koom tes haus txoj kev tshawb kawm no yuav qhib kev rau cov neeg uas tau FoodShare EBT siv lawv cov nyiaj yuav tej khoom noj hauv cov khw, kom muaj kev nthuav dav, thiab kom cov tswv muag khoom ho muag tau ntau zog thiab tau nyiaj. Kuv to taub hais tias kuj yuav muaj tej yam tsis tau mee txaus hauv kev koom tes no, xws li yuav muag tau cov EBT tokens ntau npaum li cas, thiab seb ho puas yuav muaj kev cuam tshuam li cas rau qhov kev siv wireless (yam li thaum raug kev txwv tej khoom uas muag tau los ntawm kev sis cov EBT token). Kuv txaus siab yuav tsis tib lub khw tshav puam uas muab kev koom tes thiab lub University of Wisconsin Cooperative Extension Waukesha County yog muaj teeb meem tshwm sim ntawm kev tshawb kawm no.

Raws li ib tug uas muab kev koom tes rau kev tshawb kawm no, kuv pom zoo:

- Yuav teb cov lus thiab kos npe rau Tsab Ntawv Txaus Siab (Participation Agreement) thiab yuav muab tsab ntawv no rau tus manager hauv lub khw tshav puam los yog tus EBT program manager
- Yuav muab daim paib "We Accept EBT Tokens" tsa los yog dai kom neeg pom raws li lub khw muab rau kuv.
- Qhia rau cov neeg tuaj kav khw kom lawv paub hais tias yuav ua li cas lawv thiaj mus nqa tau cov "Farmers' Market EBT Tokens" ntawm tus manager lub rooj.

- TSUAS TXAIS cov Farmers’ Market EBT Tokens uas yog muaj lub khw koj muag khoom ntawd lub npe xwb thaum lub sij hawm lub khw qhib muag khoom.
- TSUAS TXAIS cov Farmers’ Market EBT Tokens los pauv cov khoom noj thiab khoom cog uas muaj feem tau FoodShare/EBT Program raws li USDA Food and Nutrition Service Department cov cai.
- Tsis ntxiv nyiaj ntsuab thaum siv cov EBT token. Yog yuav khoom tsawg dua \$1.00, yuav tau yuav me ntsis khoom ntxiv kom haum los sis muab nyiaj ntsuab them.
- Muab cov EBT tokens uas cov neeg tuaj kav khw them coj mus pauv ntawm lub khw los sis tus EBT program manager, raws li tus txheej txheem hauv lub khw.
- Hwm thiab ua qhov zoo rau txhua tus neeg tuaj kav kiab.
- Yog hais tias muaj teeb meem dab tsi txog qhov program no ces ceeb toom rau lub khw tus manager los yog tus EBT program manager thiab lub University of Wisconsin Cooperative Extension Waukesha County.
- Muab daim ntawv tshawb kawm annual project farmer/vendor no teb kom tiav.
