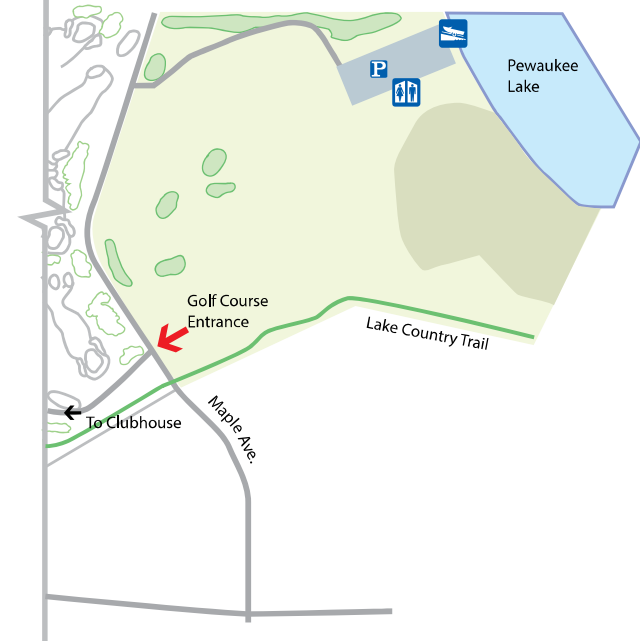

Naga-Waukeee Park is part of the Waukesha County Park System. This 8,500-acre, natural resources-based system consists of diverse landscapes, high-quality natural areas, a variety of trails, and beautiful lakes, ponds, and waterways.

This 414-acre parcel contains a 206-acre regional park along the shores of Nagawicka Lake. The diverse topographical features that were created during the glacial age offers many recreational opportunities and the boardwalk has spectacular views for great photo opportunities.

The oak hickory forest and thick undergrowth define the trails that wind throughout the park, which is home to many different species of wildlife. Catch glimpses of baltimore orioles, tufted titmouse, hooded warblers, and great horned owls throughout Naga-Waukeee Park.

Naga-Waukeee War Memorial Golf Course also makes up this large parcel. The 18-hole championship golf course was designed by golf course architect Lawrence Packard. The rugged terrain and breathtaking views of Pewaukee Lake make playing this course an unforgettable experience.

Lake access sites managed by Park System staff at Pewaukee, Nagawicka, and Nemahbin Lakes provide boat launches for getting out on the water with a Daily Lake Access Permit or Annual Lake Access Membership.

PARK SYSTEM RULES

- Hours: Sunrise to 10 p.m.
- Speed Limit: 15 MPH
- Required: Daily Park Permit or Annual Park Membership for each vehicle.* Pay within five days to avoid a violation: wauk.co/webtrac
- Keep parks safe and fun for all: Stay on designated trails.
- Bicycles allowed on designated trails only.
- Parking in designated parking areas only.
- Fires in reserved facility's grill and/or fireplace only. No carry-in wood allowed.
- Beer and wine: Picnic permit required. Absolutely no hard liquor.
- Adult supervision required at all times for Youth Organizations (under 18 years old).
- Hunting, shooting, or trapping: Permitted on designated properties only.
- Three dogs maximum per handler.* Handlers must: (1) Retain control of dog(s) at all times. (2) Remove and dispose of dog waste in a sanitary manner.

- All dogs must be leashed (6' or less), unless in a designated Dog Exercise Area or Dog Swim Area. Electronic leashes or collars are not considered a leash.
- Guests must follow all posted rules, including those for Beaches, Camping, Dog Exercise Areas, Dog Swimming, and Mountain Bike trails. Additional rules may apply; see website.

*No fees or dogs at Retzer Nature Center.

RECREATIONAL OPPORTUNITIES

- **Beach:** The beach along Nagawicka Lake has a Beach House building and vending machines. Offering Swim At Your Own Risk hours, pending weather and water quality. Hours are sunrise to sunset.
- **Biking:** Access the Lake Country Trail from the Park. No bikes on unpaved trails.
- **Boating:** The lake access areas allow you to enjoy the lake through fishing, sailing, water skiing, canoeing, power boating, and more! Daily Lake Access Permit or Annual Lake Access Membership required for all vehicles that enter the lake access area.
- **Camping:** Reserve a group or family camp site online.
- **Fishing:** You can catch northern, walleye, bass, bluegill, perch, and crappies. We encourage and support the catch and release of fish. No fishing within 40 feet of pier.
- **Golfing:** Naga-Waukeee War Memorial Golf Course is a challenging 18-hole course with rugged terrain and scenic views of Pewaukee Lake. Located east of the Park off of Maple Ave. For tee times call (262) 367-2153 or visit: www.golfwaukeshacounty.com.
- **Hiking:** Trails of varying difficulty and length for all hikers.
- **Nature Viewing:** See a wide variety of plants, animals, and birds. Report observations to the County's iNaturalist.org "Wild in Waukesha" page or eBird.org.
- **Picnicking:** Grill at a first come, first served family picnic area or reserve a picnic area shelter online for an event.

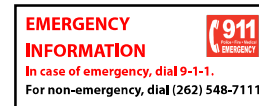
RENTAL FACILITIES

Picnic Areas: Five reservable picnic areas are available with concrete base covered area, picnic tables, indoor restrooms, electric, water, large grill, and sand volleyball court with net.

Beach House: Available to rent from November - March for private events. This heated facility has a capacity of 20 and includes indoor restrooms.

CAMPING

- 25 Family Campsites. Site fee includes up to 2 camping units and 2 vehicles maximum.
- 5 Group Campsites (4 electric). Site fee includes up to 3 camping units. Check online for vehicle capacity. Park staff will collect for additional units daily.
- Daily Park Permit or Annual Park Membership required for all vehicles.
- Campers must be 18 years old or with a parent/legal guardian.
- Quiet time 10 p.m. - 7 a.m.
- Seven (7) night camping limit; check in 3 p.m., check out noon.
- All firewood must be purchased at the Park. No carry-in wood allowed. Self-serve firewood by Park Office is available when Park Ranger is not on duty.
