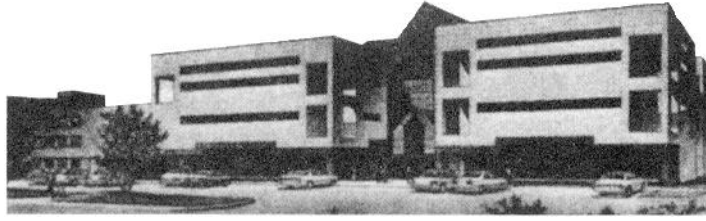

### ***News Release Update***

***March 27, 2025***

The Waukesha County Sheriff's Department, in close collaboration with the Waukesha County District Attorney's Office, has announced significant developments in the ongoing investigation involving Nikita Casap. In light of new evidence and findings, Mr. Casap has been formally charged with several new offenses. The charges include:

- 2 Counts of 1st Degree Intentional Homicide
- 2 Counts of Hiding a Corpse
- Theft of Property Over \$10,000
- 2 Counts of Misappropriating ID to Obtain Money

The Sheriff's Department remains steadfast in its commitment to a thorough and transparent investigative process, ensuring justice is served. We continue to work diligently to gather all pertinent information and evidence in this case.

## ***Update March 12th, 2025***

The Waukesha County Sheriff's Department confirms that 17-year-old Nikita Casap has been formally charged with Operating a Motor Vehicle Without the Owner's Consent and Theft. Nikita Casap is currently in custody, and it is important to note that additional felony charges are forthcoming.

Nikita Casap remains a person of interest in the ongoing investigation into the deaths of his mother, Tatiana Casap, and stepfather, Donald Mayer. Our detectives are actively pursuing all leads and working diligently to gather evidence related to this case. The Waukesha County Sheriff's Department remains dedicated to conducting a comprehensive investigation with integrity and continues to work closely with the Waukesha County District Attorney's Office to ensure justice is served.

## ***Update March 5th, 2025***

The Waukesha County Medical Examiner's Office has positively identified the two deceased individuals as Donald Mayer (51) and Tatiana Casap (35). The identification process necessitated a delay due to the need for the highest level of accuracy, ensuring both thoroughness and respect for the deceased and their families.

Additional time was required to notify Tatiana's next of kin, who resides outside of the United States. The Waukesha County Sheriff's Department coordinated translation services to facilitate effective communication, ensuring that all notifications were handled with maximum sensitivity and care.

We extend our deepest condolences to the families of Donald and Tatiana during this challenging time. Thank you for your understanding and patience as we worked diligently to provide accurate and respectful communication.

## ***Update March 4th, 2025***

The Waukesha County Sheriff's Department announces the completion of autopsies for both victims in this ongoing investigation. Tentative identifications have been established, but our investigators, in partnership with the Medical Examiner's Office, are actively engaged in confirming their identities as part of the investigative process.

#### Death Investigation Village of Waukesha

On Friday, February 28th, 2025, at 9:44 a.m., the Waukesha County Communications Center received a call requesting a welfare check on a family residing in the Village of Waukesha. Deputies responded to the scene and discovered one resident deceased. At this time, the whereabouts of the other family members remain unknown.

The Waukesha County Sheriff's Department is actively investigating the situation and working to determine the circumstances surrounding the incident. Further information will be provided as it becomes available. At this time, the Waukesha County Sheriff's Department does not believe there is a threat to the community.
