WHEREAS, Section 15-87 currently authorizes the director of parks and land use to designate to employees employed as park rangers and park ranger coordinator the ability to issue citations authorized by this section: and

WHEREAS, the department of Parks and Land Use is evaluating entering into a service agreement with a local law enforcement agency to issue citations authorized by this section.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that section 15-87 (1) of the Waukesha County Code is hereby amended as follows:

(1) The Department of Parks and Land Use shall enforce the provisions of this section. The Director of Parks and Land Use may designate citation authority to employees employed as park rangers or park ranger coordinator and is authorized to enter into written agreements with local law enforcement agencies delegating the enforcement of this section.

### FISCAL NOTE

## AMEND THE TEXT OF CHAPTER 15, ARTICLE III OF THE WAUKESHA COUNTY CODE OF ORDINANCES TO UPDATE PROVISIONS REGARDING PARKING AT THE COUNTY COURTHOUSE AND OFFICE BUILDINGS

This ordinance modifies the County Code of Ordinances to allow the Department of Parks and Land Use to enter into agreements with local law enforcement agencies to enforce parking rules and issue citations at the County Courthouse and office buildings. Currently, the department can only designate county staff employed as park rangers and park ranger coordinators.

Department management indicates that it is in discussions with the city of Waukesha Police Department to take on this responsibility, and that agency would be compensated by retaining the base forfeiture of the parking citation. Citations may be issued for unauthorized parking in reserved spaces, violating time restrictions, and parking outside designated stalls or in violation of signage. County code specifies that citations will not be less than \$10 or more than \$50 for each offense. The fiscal impact to the county would be the loss of this citation revenue, which is budgeted at \$500 in 2025 and varies on an actual basis from year-to-year (less than \$10,000 annually over the last decade).
