

**ALL FEES ARE PRE PAY**

**Civil Process Service Fee:** \$60.00 – Up to 3 attempts for 1 person / business at 1 address  
\$30.00 – Up to 3 attempts for each additional person at same address

**Civil Process Service Fee Out of State:** \$61.00 – Up to 3 attempts for 1 person / business at 1 address  
\$31.00 – Up to 3 attempts for each additional person at same address

**Writ of Replevin:** \$560.00 + Bond – Up to 3 attempts

**Writ of Replevin (Vehicle):** \$560.00 – Up to 3 attempts, no bond needed if VIN # and description provided

**Writ of Execution:** \$560.00 + Bond for 2X the amount of Judgment – VIN #'s MUST be on bond

**Writ of Execution:** \$75.00 for making a demand for money

**Execution Against Property:** Fee Determined by Captain or Lieutenant

**Writ of Eviction/Restitution:**

**Apartment:** \$1,060.00 or \$560.00 and a Letter of Authority from a bonded moving company

**House:** \$1,560.00 or \$560.00 and a Letter of Authority from a bonded moving company

**Business:** \$2,060.00 (and up) or \$560.00 and a Letter of Authority

**Writ of Assistance:**

\$1,560.00 (and up) Depending on the size of house

\$1,500.00 TO HIRE EAGLE MOVERS / (1,000 SQUARE FEET OR LESS = \$1,000)
