WHEREAS, the matter was referred to and considered by the Waukesha County Park and Planning Commission, which recommended approval and reported that recommendation to the Land Use, Parks and Environment Committee and the Waukesha County Board of Supervisors, as required by Section 60.62, Wis. Stats.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the District Zoning Map for the Town of Delafield Zoning Code, adopted by the Town of Delafield on July 20, 1998, is hereby amended to conditionally rezone from the A-2 Rural Home District to the A-3 Suburban Home District, certain lands located in part of the NE ¼ of the NW ¼ of Section 33, T7N, R18E, Town of Delafield, Waukesha County, Wisconsin, as more specifically described in the "Staff Report and Recommendation" and map on file in the office of the Waukesha County Department of Parks and Land Use and made a part of this Ordinance by reference, is hereby approved, subject to the following conditions:

- 1. The land division shall substantially conform to that as depicted upon Exhibit A and, prior to the north driveway being constructed, the local fire inspector shall be consulted and tree removal, grading and erosion control plans shall be reviewed and approved by the town and county.
- 2. No residence shall be constructed in the Primary Environmental Corridor (PEC).
- 3. Disturbance through the primary environmental corridor for access to a residence shall be minimized and the only land that can be disturbed is for a driveway corridor which shall be no greater than 24 feet wide.

BE IT FURTHER ORDAINED that the Waukesha County Clerk shall file a certified copy of this Ordinance with the Town Clerk of Delafield.
