MODIFY THE WAUKESHA DEPARTMENT OF HEALTH AND HUMAN SERVICES 2024  
BUDGET TO APPROPRIATE EXPENDITURES AND AUTHORIZE DHHS TO ACCEPT  
THE CASH DONATION FROM FROEDTERT HEALTH

WHEREAS, the mission of the Waukesha County Department of Health and Human Services, Public Health Division, is to champion innovative programs and partnerships to foster optimal health and well-being for our community; and

WHEREAS, Wisconsin state statute requires health departments to develop and implement a Community Health Improvement Plan (CHIP) to address health conditions impacting their residents while partnering with organizations to cultivate community ownership; and

WHEREAS, Froedtert Health, a co-chair of the Waukesha County CHIP, will donate \$3,500 to the CHIP kickoff process to increase visibility and recognition of the process; and

WHEREAS, the Department of Health and Human Services will use the \$3,500 cash donation to support the 2024 CHIP kickoff event.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services is authorized to accept the \$3,500 cash donation from Froedtert Health for the specific use of supporting the 2024 CHIP kick-off event.

BE IT FURTHER ORDAINED that the 2024 Waukesha County Department of Health and Human Services budget be modified by increasing operating expenses by \$3,500 and other revenues by \$3,500.
