AUTHORIZE THE SHERIFF'S DEPARTMENT TO AMEND THE 2010-2014 MUNICIPAL PATROL CONTRACT WITH THE CITY OF PEWAUKEE TO ALLOW FOR TARGETED TRAFFIC ENFORCEMENT AND MODIFY THE 2013 SHERIFF'S DEPARTMENT BUDGET BY APPROPRIATING \$11,000

WHEREAS, the City of Pewaukee has requested that the Waukesha County Sheriff's Department provide additional traffic enforcement in an effort to improve vehicular safety, and

WHEREAS, the existing municipal patrol contract does not clearly allow the Department to work with the City to provide the additional traffic enforcement, and

WHEREAS, a contract amendment has been drafted for consideration by both the City of Pewaukee City Council and the County Board to allow the Sheriff's Department to execute an amendment to the existing municipal patrol contract to provide the additional requested targeted traffic enforcement, and

WHEREAS, the City of Pewaukee is willing to pay an amount not to exceed \$11,000 for the overtime expenses that will be generated through the additional targeted enforcement efforts through December 31, 2013.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY ORDAINS that the contract amendment on file with the Waukesha County Sheriff's Department to provide additional targeted traffic enforcement to the City of Pewaukee is hereby approved and the Waukesha County Sheriff is authorized to execute the contract.

BE IT FURTHER ORDAINED that the Sheriff's Department 2013 budget be modified by increasing charges for services revenue by an additional \$11,000, and increasing the department's personnel cost appropriation unit by \$11,000 to cover overtime costs associated with the targeted enforcement activities.
