WHEREAS, Wisconsin Statutes Section 66.0602 limits the ability of towns, villages, cities, and counties to levy increases in property taxes to the percentage growth in net new construction, which includes allowances for the carryover of unused levy authority from prior years, among other adjustments; and

WHEREAS, Section 66.0602(3)(f)3.a., Wisconsin Statutes allows cities, villages, and counties with governing bodies greater than five (5) members to carryover unused levy authority up to 0.5% of the prior-year levy, if approved by a majority vote, and up to 1.5%, if approved by a three-quarters majority; and

WHEREAS, the general county property tax levied for 2025 budget purposes was \$19,990 below the allowable levy limit; and

WHEREAS, the 2026 County Executive Proposed Budget assumes the carryover of this \$19,990, which is less than 0.5% of the prior year's tax levy, and will require a majority vote of the County Board to approve.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that carryover of unused property tax levy authority from the 2025 budget to the 2026 budget in the amount of \$19,990 is approved.
