MODIFY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES 2025 BUDGET TO ACCEPT THE WISCONSIN DEPARTMENT OF HEALTH SERVICES STATE HEALTH INSURANCE ASSISTANCE PROGRAM GRANT AND APPROPRIATE ADDITIONAL EXPENDITURES

WHEREAS, the Wisconsin Department of Health Services (DHS) has awarded the Waukesha County Department of Health and Human Services (WCDHHS) a State Health Insurance Assistance Program (SHIP) grant of \$26,544 to be used between April 1, 2025 and March 31, 2026; and

WHEREAS, the goal of the DHS State Health Insurance Assistance Program is to provide unbiased education, counseling and enrollment assistance to all people with Medicare; and

WHEREAS, WCDHHS Aging and Disability Resource Center will utilize the funding to provide one-on-one Medicare counseling services on Medicare enrollment options and outreach to the public regarding Medicare-related topics, including Medicare enrollment, low-income assistance programs, preventive services, and the availability of SHIP counseling services at WCDHHS; and

WHEREAS, WCDHHS will utilize the SHIP grant funding to cover the cost of a 0.50 LTE Human Services Support Specialist position to execute the work of the grant requirements; and

WHEREAS, available revenues were not anticipated nor included in the 2025 budget; and

WHEREAS, WCDHHS is proposing to amend the 2025 adopted budget by increasing general government revenue by \$26,544 and increasing personnel expenses by \$26,544.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services is authorized to accept the Wisconsin Department of Health Services State Health Insurance Assistance Program grant of \$26,544.

BE IT FURTHER ORDAINED that the 2025 Waukesha County Department of Health and Human Services – ADRC Contract Fund budget be modified to increase general government revenue by \$26,544, and personnel expenses by \$26,544 to provide outreach, counseling and enrollment assistance to the public regarding Medicare-related topics.

MODIFY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES 2025 BUDGET TO ACCEPT THE WISCONSIN DEPARTMENT OF HEALTH SERVICES STATE HEALTH INSURANCE ASSISTANCE PROGRAM GRANT AND APPROPRIATE ADDITIONAL EXPENDITURES

This ordinance authorizes the 2025 Department of Health and Human Services to accept \$26,544 of State Health Insurance Assistance Program (SHIP) grant funding from the Wisconsin Department of Health Services to provide one-on-one Medicare counseling services on Medicare enrollment options and outreach to the public regarding Medicare-related topics, including Medicare enrollment, low-income assistance programs, preventive services, and the availability of SHIP counseling services. The ordinance also modifies the department's Aging and Disability Resource Center Contract Fund budget to increase personnel costs by \$26,544 for a 0.50 FTE limited-term employment (LTE) position (Human Services Support Specialist) to carry out the grant, offset with the same increase in general government revenue. LTE positions generally do not receive the same benefits (e.g., health insurance, dental insurance) as regular full-time and part-time positions, and do not require separate County Board approval for their creation, aside from the budget appropriation. The term of the grant is from April 1, 2025 to March 31, 2026.
