



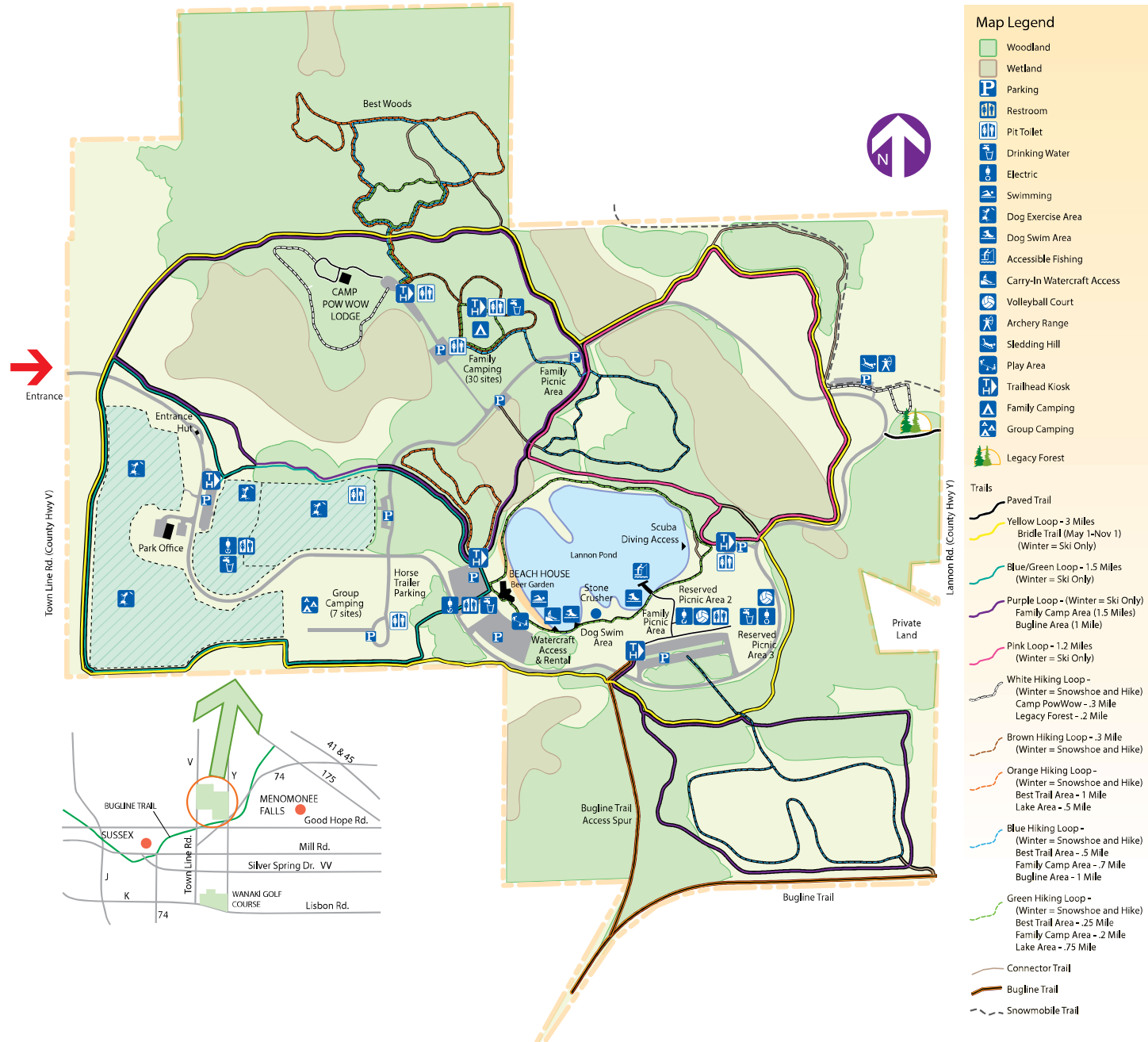

Menomonee Park is located in the Villages of Lannon and Menomonee Falls and offers countless recreational opportunities. It features 470 acres of rolling fields and shrublands, high quality maple woods, wetlands, and a 16-acre quarry pond with a large beach.

From 1880-1900, a stone quarry operated on the property, and several historical remnants of the operation still exist in the Park, including an old stone crusher and a railroad spur connection that is now a link to the Bugline Trail. The Bugline is a 16-mile paved trail that runs from Menomonee Falls to North Lake. There are also many miles of unpaved trails within the Park. In the winter, many of the trails are also available for cross-country skiers and snowshoers.

The "Best Woods" are some of the highest quality woods in the entire Park, full of spring wildflowers and calling birds in summer. There are also three artesian wells in the Park.

PARK SYSTEM RULES

- Hours: Sunrise to 10 p.m.
- Speed Limit: 15 MPH
- Required: Daily Park Permit or Annual Park Membership for each vehicle.* Pay within five days to avoid a violation: wauk.co/webtrac
- Keep parks safe and fun for all: Stay on designated trails.
- Bicycles allowed on designated trails only.
- Parking in designated parking areas only.
- Fires in reserved facility's grill and/or fireplace only. No carry-in wood allowed.
- Beer and wine: Picnic permit required. Absolutely no hard liquor.
- Adult supervision required at all times for Youth Organizations (under 18 years old).
- Hunting, shooting, or trapping: Permitted on designated properties only.
- Three dogs maximum per handler.* Handlers must: (1) Retain control of dog(s) at all times. (2) Remove and dispose of dog waste in a sanitary manner.
- All dogs must be leashed (6' or less), unless in a designated Dog Exercise Area or Dog Swim Area. Electronic leashes or collars are not considered a leash.
- Guests must follow all posted rules, including those for Beaches, Camping, Dog Exercise Areas, Dog Swimming, and Mountain Bike trails. Additional rules may apply; see website.

*No fees or dogs at Retzer Nature Center.

RECREATIONAL OPPORTUNITIES

- Archery:** Range with 4 targets, including 1 crossbow, and a raised platform.
- Beach:** A 16-acre quarry pond with a swimming beach and Beach House. Offering Swim At Your Own Risk hours, pending weather and water quality. Hours are sunrise to sunset.
- Beer Garden:** Open May - October! More information at www.thetapyards.com.
- Biking:** Paved trail through the Park, with access to the Bugline Trail. No biking on unpaved trails.
- Boating:** Rent a kayak from our partner vendor or bring your own to use from the designated carry-in watercraft launch site. Non-motorized or electric motors only.
- Camping:** Reserve a group or a family camp site online.
- Dog Exercise Area:** Enjoy the fenced-in large (18 acres), small (7 acres) or all (6 acres) breed areas where your dog is free to run off lead.
- Dog Swimming Area:** Designated area for off-leash dog swimming only.
- Fishing:** From the accessible fishing pier you can catch trout, bass, bluegill, perch, and crappies. We encourage and support the catch-and-release of fish. The pond is part of the DNR's Urban Fishing Program. Ice fishing can be enjoyed during the winter months.
- Hiking:** Trails of varying difficulty and length for all enthusiasts. Some trails open during winter for hiking and snowshoeing (not permitted on groomed trails).
- Horseback Riding:** Bridle trail through the park is available from May - November. Only on the Yellow Trail.
- Nature Viewing:** See a wide variety of plants, animals, and birds. Report observations to the County's iNaturalist.org "Wild in Waukesha" page or eBird.org.
- Picnicking:** Grill at a first come, first served family picnic area or reserve a picnic area shelter online for an event.
- Scuba Diving:** Explore the underwater world. A permit and release form is required and is available online.
- Sledding:** Sleds, tubes, and snowboards allowed on designated sledding hill. Parking available at archery lot.
- X-Country Skiing:** Groomed and tracked cross-country ski trails for both classical and skate techniques. There are three loops on gently rolling terrain.

RENTAL FACILITIES

- Picnic Areas:** Two reservable picnic areas are available with a covered area, picnic tables, flush restrooms, electric, water, large grill, and sandpit volleyball court with net.
- Camp PowWow Lodge:** Available to rent Sept - May. This

heated facility has a banquet capacity of 130 and theatre capacity of 150 and includes a refrigerator, stove, oven, freezer, sink, fireplace, indoor restrooms, and patio.

CAMPING

- 30 Family Campsites. Site fee includes up to 2 camping units and 2 vehicles maximum.
- 7 Group Campsites. Site fee includes up to 5 camping units. Park staff will collect for additional units daily. Check online for vehicle capacity.
- Daily Park Permit or Annual Park Membership required for all vehicles.
- Campers must be 18 yr. old or with a parent/legal guardian.
- Quiet time 10 p.m. - 7 a.m.
- Seven (7) night camping limit; check in 3 p.m., check out noon.
- All firewood must be purchased at the Park. No carry-in wood allowed. Self-serve firewood by Park Office is available when Park Ranger is not on duty.
- Parking on designated pavement or gravel only. Additional vehicles must park in designated areas.
- Flush restrooms and showers in Beach House building.
- The Park does not have dump stations. A list of dump stations is available at www.waukeshacounty.gov/camping.
