

ENROLLED ORDINANCE 178-95

ESTABLISH AND APPROVE THE DEPARTMENT OF HEALTH AND HUMAN SERVICES
2024 FEES FOR COMMUNITY MENTAL HEALTH, DEVELOPMENTAL DISABILITIES,
AND SUBSTANCE USE DISORDER SERVICES

WHEREAS, the Waukesha County Department of Health & Human Services (HHS) provides billable services to clients for community mental health, developmental disabilities, and substance use disorders under §51.42, Wisconsin Statutes; and

WHEREAS, DHS 1.03(2), Wisconsin Administrative Code, requires the Waukesha County Board to annually establish and approve the usual and customary fee schedule for community mental health, developmental disabilities, and substance use disorders; and

WHEREAS, the establishment of these fees is required by third-party payors and helps approximate the cost of providing the services; and

WHEREAS, HHS contracts with various insurance providers and charges a lower, contracted rate, similar to Medicare approved rates, for services provided to a client with a contracted insurance provider; and

WHEREAS, the usual and customary fee schedule for 2024 will increase seven percent over the 2023 schedule; and

WHEREAS, the 2024 HHS budget contemplated increases in the 2024 usual and customary fee schedule and contracted rates and no budget modification is necessary.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the 2024 usual and customary fee schedule, unless otherwise specified by contract, for community mental health, developmental disabilities, and substance use disorder services, as indicated in Table 1 on file with the Department of Health & Human Services and made part of this ordinance by reference, be approved.







1 ESTABLISH AND APPROVE THE DEPARTMENT OF HEALTH AND HUMAN SERVICES
2 2024 FEES FOR COMMUNITY MENTAL HEALTH, DEVELOPMENTAL DISABILITIES,
3 AND SUBSTANCE USE DISORDER SERVICES
4

5 WHEREAS, the Waukesha County Department of Health & Human Services (HHS) provides
6 billable services to clients for community mental health, developmental disabilities, and
7 substance use disorders under §51.42, Wisconsin Statutes; and
8

9 WHEREAS, DHS 1.03(2), Wisconsin Administrative Code, requires the Waukesha County
10 Board to annually establish and approve the usual and customary fee schedule for community
11 mental health, developmental disabilities, and substance use disorders; and
12

13 WHEREAS, the establishment of these fees is required by third-party payors and helps
14 approximate the cost of providing the services; and
15

16 WHEREAS, HHS contracts with various insurance providers and charges a lower, contracted
17 rate, similar to Medicare approved rates, for services provided to a client with a contracted
18 insurance provider; and
19

20 WHEREAS, the usual and customary fee schedule for 2024 will increase seven percent over the
21 2023 schedule; and
22

23 WHEREAS, the 2024 HHS budget contemplated increases in the 2024 usual and customary fee
24 schedule and contracted rates and no budget modification is necessary.
25

26 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS
27 that the 2024 usual and customary fee schedule, unless otherwise specified by contract, for
28 community mental health, developmental disabilities, and substance use disorder services, as
29 indicated in Table 1 on file with the Department of Health & Human Services and made part of
30 this ordinance by reference, be approved.
