WHEREAS, the Waukesha County UW-Extension Department applies research and educational outreach programs to strengthen Waukesha County citizens, youth, families, businesses, and communities by developing partnerships with community organizations; and

WHEREAS, education is provided to protect the environment, assist communities with growth and change, enhance health and well-being, increase agriculture and horticulture productivity, and community and economic development; and

WHEREAS, the Waukesha County UW-Extension Department was awarded \$12,300 in grant revenue from the Greater Milwaukee Foundation for engaging Waukesha youth in Farm to School education; and

WHEREAS, the Farm to School Program will increase positive health indicators of students in the Waukesha school district, increase long-term healthy eating behaviors of students and families, and increase local foods on the school menu. The Farm to School Program will also increase family and volunteer participation in school garden and nutrition activities while encouraging civic engagement in the Waukesha community; and

WHEREAS, the Greater Milwaukee Foundation grant was neither anticipated nor included in the 2024 budget.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County UW-Extension Department is hereby authorized to accept the grant specified in this ordinance in the total amount of \$12,300 for engaging Waukesha youth in Farm to School education.

BE IT FURTHER ORDAINED that the Waukesha County UW-Extension Department's 2024 budget be modified by increasing the department's operating expenditure appropriation unit by \$12,300 and other revenues by \$12,300.
