AMEND THE 2016 SHERIFF'S DEPARTMENT BUDGET FOR THE PURCHASE OF RIFLE OPTICS

WHEREAS, in 2004 and 2008 the Sheriff's Department utilized seized funds to purchase rifle optics for the tactical enforcement unit, and

WHEREAS, the manufacturer of the rifle optics recently lost a lawsuit due to defects with the type of optics that the Department purchased, and

WHEREAS, in response to the lawsuit, the manufacturer is offering to refund agencies the full purchase price of the rifle optics, and

WHEREAS, the County's financial records indicate that that the Department paid approximately \$8,800 for the rifle optics, and

WHEREAS, the Sheriff's Department is requesting to utilize the refund revenue to purchase replacement rifle optics.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the refund revenue be appropriated by increasing in the 2016 Other Revenue appropriation unit by \$8,800 and increasing the Operating Expense appropriation unit by \$8,800 to allow for the purchase of replacement rifle optics.

FISCAL NOTE

AMEND THE 2016 SHERIFF'S DEPARTMENT BUDGET FOR THE PURCHASE OF RIFLE OPTICS

This ordinance authorizes the Waukesha County Sheriff's Department to appropriate funds that the Department will receive by returning 27 rifle optics in order to purchase replacement rifle optics.

The manufacturer that the Department purchased the rifle optics from in 2004 and 2008 recently lost a lawsuit related to optic accuracy problems discovered by the Department of Defense and the Department of Homeland Security. In response to the lawsuit, the manufacturer is no longer selling the optics and is offering agencies who return the existing optics a full refund of the purchase price regardless of when the optics were purchased. The Sheriff's Department is requesting approval to appropriate \$8,800 in revenue that will be received by returning the optics to purchase replacement optics.

This ordinance results in no additional direct tax levy impact in 2016.
