AUTHORIZE THE EXECUTION OF A QUIT CLAIM DEED RETURNING CERTAIN
COUNTY-OWNED PROPERTY TO THE VILLAGE OF BUTLER

WHEREAS, Waukesha County owns certain real property located in the Village of Butler, Waukesha County, Wisconsin, identified as Tax Key Nos. BV 0144.020 and BV 0144.027; and

WHEREAS, the subject properties were originally conveyed by the Village of Butler to Waukesha County by Warranty Deed recorded November 1, 1966, as Document No. 673405; and

WHEREAS, the Village of Butler has expanded municipal facilities, park operations, and related improvements in the vicinity of the subject properties and has requested that ownership of the properties be returned to the Village to facilitate continued management and operation of those facilities; and

WHEREAS, Waukesha County has determined that the properties are no longer necessary for County purposes; and

WHEREAS, returning the properties to the Village of Butler will place ownership and maintenance responsibility with the local municipality and is in the public interest.

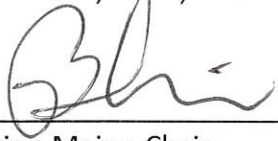
