

ENROLLED ORDINANCE 174-059

ACCEPT FOUR DONATED OUTDOOR KENNELS FOR THE CANINE UNIT

WHEREAS, the Waukesha Deputy Sheriff's Association expressed an interest in donating four new outdoor kennels for the Canine Unit with a total value of \$15,000; and

WHEREAS, the current kennels are deteriorating and will need to be replaced; and

WHEREAS, Waukesha County Code Section 7.91(b)4 requires that in-kind donations with a replacement value of five thousand dollars (\$5,000) or more, as determined by the recipient department or those subject to a special condition, must be accepted by the County Board; and

WHEREAS, the total value of the four outdoor kennels is approximately \$15,000.




This ordinance results in no additional direct tax levy impact.





