The source and date of the determination of the identified natural areas shall also be identified.

THE FOLLOWING INFORMATION MUST ALSO BE SUBMITTED WITH THIS APPLICATION: an existing and proposed grading plan, including the area of disturbance; a drainage plan; timetable for completion; type, source, and amount of fill; an erosion control plan; a complete vegetative plan including seeding mixtures, amount of topsoil and mulch; a cross-section elevation view of the proposal, perpendicular to the watercourse showing if the proposed development will obstruct flow; and an analysis calculating the effects of this proposal on regional flood height. If the floodplain does not have an established elevation or floodway, a hydraulic and hydrologic study must be submitted for review and approval. If flood water storage is reduced, plans illustrating 100% compensation for any lost flood storage capacity must be submitted for review and approval.

AN INCOMPLETE APPLICATION FORM OR MISSING INFORMATION WILL CAUSE DELAY IN THE ISSUANCE OF THE ZONING PERMIT, AND THE APPLICATION MAY BE RETURNED FOR ADDITIONAL INFORMATION. CONSTRUCTION MUST BE COMPLETED WITHIN 6 MONTHS OF THE DATE OF ISSUANCE OF THE ZONING PERMIT UNLESS OTHERWISE SPECIFIED.

The undersigned states that the foregoing information is true and accurate to the best of his/her knowledge; it is hereby agreed that for and in consideration of the issuance of a zoning permit that the foregoing work will be carried out as defined in this application; that all applicable ordinances or codes of the state, county, and town will be complied with in carrying out the proposed work stated in the application; and that work will not commence before a building permit has been obtained from the town building inspector. If any changes or deviations are made from the original application, a new permit is required. Failure to comply with the permit as issued will result in the revocation of the permit or other penalties. By signing this form, the owner/applicant is giving consent for the Department of Parks and Land Use to inspect the site as necessary and related to this application even if the property has been posted against trespassing pursuant to Wis. Stat.; and serves as your acceptance of the wetland statement included on your Property Owner letter issued with your permit.
