# AUTHORIZE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO ACCEPT AND APPROPRIATE A CHARITABLE DISTRIBUTION FROM THE ESTATE OF ANNA VERENA FJERMESTAD REVOCABLE LIVING TRUST AND AMEND THE 2016 BUDGET

WHEREAS, the Estate of Anna Verena Fjermestad Revocable Living Trust has provided Waukesha County Department of Health and Human Services a charitable distribution from the trust in the amount of \$10,000 to support the work of the Department with people with mental disabilities, and

WHEREAS, the Clinical Division has determined that the best use of this funds would be to expand on the purchase of certified peer specialist services for clients receiving services from Waukesha County Department of Health and Human Services, and

WHEREAS, Peer Specialists are trained and certified by the State of Wisconsin to serve as advocates and provide information and peer support for members in community settings in accordance to a member's individual recovery plan, and

WHEREAS, these services also help members negotiate the mental health and/or substance abuse system with dignity and without trauma through a mutually empowering relationship, and

WHEREAS, this charitable distribution will allow the Department of Health and Human Services to purchase a peer specialist for approximately 5 hours per week for a period of one year, and

WHEREAS, the 2016 adopted budget did not anticipate nor include revenue and expenditure authority for the \$10,000 charitable distribution.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that Waukesha County Department of Health and Human Services is authorized to accept the \$10,000 from the Estate of Anna Verena Fjermestad Revocable Living Trust.

BE IT FURTHER ORDAINED that the Waukesha County Department of Health and Human Services 2016 budget be modified to increase Operating Expense appropriation by \$10,000 and increase Other Revenue by \$10,000 to cover costs associated with purchasing certified peer specialist services.
