The south side of Wisconsin Avenue from Oak Lane east to Jaeckles Drive – Establishment of No Parking 2:00 a.m. to 6:00 a.m., and

The north side of Wisconsin Avenue from Oak Lane east to Jaeckles Drive – Establishment of No Parking.

BE IT FURTHER ORDAINED that this declaration rescinds all other previous restrictions for the above described portion of the County Trunk Highway System.
