CREATE A NO PARKING REGULATION FOR COUNTY TRUNK HIGHWAY B (VALLEY ROAD) BETWEEN CTH P (SAWYER ROAD) AND N. MILL ROAD IN THE VILLAGE OF SUMMIT

WHEREAS, CTH B (Valley Road) between CTH P (Sawyer Road) and N. Mill Road is designated a Rustic Road, and the curving road rides the narrow isthmus between Upper and Lower Nashotah Lakes; and

WHEREAS, the Rustic Roads program was created over 45 years ago to provide hikers, bicyclists and motorists an opportunity to leisurely travel through the state's scenic countryside; and

WHEREAS, CTH B (Valley Road) is adjacent to both Upper and Lower Nashotah Lakes and provides access to private properties between CTH B (Valley Road) and Upper and Lower Nashotah Lakes; and

WHEREAS, no public access exists between CTH B (Valley Road) and Upper and Lower Nashotah Lakes; and

WHEREAS, people routinely park along CTH B (Valley Road) to gain access to Upper and Lower Nashotah Lakes; and

WHEREAS, there is not adequate shoulder to park along CTH B (Valley Road) without obstructing sight distance of motorists and bicyclists; and

WHEREAS, property owners along CTH B (Valley Road) have expressed concerns with driveway sight distance being obstructed by vehicles parked along CTH B (Valley Road); and

WHEREAS, in response to property owner concerns, Waukesha County has reviewed CTH B (Valley Road) between CTH P (Sawyer Road) and N. Mill Road and recommend the creation of a No Parking Anytime regulation to improve roadway safety, discourage trespass, and comply with the spirit and purpose of the Rustic Road designation; and

WHEREAS, the parking, standing and stopping of vehicles along county trunk highways can have a detrimental effect upon highway capacity and safety; and

WHEREAS, Wisconsin Statutes § 349.13 provides that local authorities may regulate the parking, standing and stopping of vehicles along such highways.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS, that the following parking regulation shall be in effect upon the placement of proper signs:


CTH B (Valley Road) from CTH P (Sawyer Road) easterly to the intersection with N. Mill Road in the Village of Summit – No Parking Anytime.
