

ENROLLED ORDINANCE 168-29

ACCEPT DONATED UNDERWATER CAMERA EQUIPMENT

WHEREAS, the Waukesha County Sheriff's Department was contacted by the LaLonde family expressing their desire to donate underwater camera equipment to the Search and Recovery Unit, and

WHEREAS, the camera equipment would be an asset to the Search and Recovery Unit by allowing staff to take pictures underwater for evidentiary purposes, and

WHEREAS, Waukesha County Code Section 7.91(b)4 requires that in-kind donations with a replacement value of two thousand dollars (\$2,000) or more as determined by the recipient department or those subject to a special condition must be accepted by the County Board, and

WHEREAS, the value of the underwater camera equipment is approximately \$2,500, and

WHEREAS, this camera equipment will not be included in a replacement plan or replacement will not be funded by levy.


