

ENROLLED ORDINANCE 179-87

AMEND WAUKESHA COUNTY BOARD OF SUPERVISORS' OPERATING  
PROCEDURES AND RULES BY AMENDING THE TEXT OF THE CODE OF  
ORDINANCES, CHAPTER 4

WHEREAS, the Waukesha County Board of Supervisors' (the "Board") Operating Procedures and Rules (the "Rules") are codified in Chapter 4 of the Waukesha County Code; and

WHEREAS, the Rules establish the manner in which the Board and its committees are constituted and conduct business to ensure orderly administration; and

WHEREAS, it is desirable to amend the Rules to address certain issues not adequately addressed by the current Rules.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that Chapter 4 of the Waukesha County Code of Ordinances be amended by the creation of the following provisions in Article III, Division 2 Rules of Order:

**Sec. 4-87 Consent Agenda.**


The County Board Chair may designate a part of the agenda as the consent agenda. Items are placed on the consent agenda if they are judged to be noncontroversial and routine. Any member may remove an item from the consent agenda and place it on the regular agenda when the consent agenda comes forward for action. All items on the consent agenda must be voted on and adopted by a single motion, with the minutes reflecting the motion and vote on each item.




