MODIFY SPEED ZONES ON THE NORTH, EAST, AND WEST APPROACHES AT THE INTERSECTION OF CTH KE (NORTH SHORE DRIVE) AND CTH E (MAPLE AVENUE)

WHEREAS, Wisconsin Statutes § 349.11 permits local authorities to modify speed restrictions within statutory guidelines; and

WHEREAS, Waukesha County maintains jurisdiction over the north, east, and west leg of the intersection of CTH KE (North Shore Drive) and CTH E (Maple Avenue), while the Town of Delafield maintains jurisdiction over the south leg; and

WHEREAS, the Town of Delafield is pursuing a speed limit modification on the south approach at the intersection of CTH KE (North Shore Drive) and CTH E (Maple Avenue); and

WHEREAS, the Department of Public Work's Capital Highway Project #202520 has been awarded federal funding for the construction of a compact roundabout at the intersection of CTH KE and CTH E; and

WHEREAS, a reduction in intersection approach speed limit will benefit the intersection safety of the proposed compact roundabout by improving the transitional speed reduction; and

WHEREAS, constructing a compact roundabout at the intersection will minimize impacts outside of the existing intersection footprint; and

WHEREAS, the Waukesha County Department of Public Works finds it appropriate, pursuant to Wisconsin Statutes § 346.57(4)(f) and § 349.11(1)(a) and (3)(c), to modify the speed zone to thirty-five (35) mph in both directions of CTH KE from 0.3 miles west of the centerline of CTH E to 0.3 miles east of the centerline of CTH E; and

WHEREAS, the Waukesha County Department of Public Works finds it appropriate, pursuant to Wisconsin Statutes § 346.57(4)(f) and §349.11(1)(a) and (3)(c), to modify the speed zone to thirty-five (35) mph in both directions of CTH E from the centerline of CTH KE to 0.3 miles north of the centerline of CTH KE; and

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the speed zone along both directions of County Trunk Highway CTH KE in the Village of Hartland and Town of Delafield is modified to thirty-five (35) mph from 0.3 miles west of the centerline of CTH E to 0.3 miles east of the centerline of CTH E and that the speed zone along both directions of County Trunk Highway CTH E in the Village of Hartland is modified to thirty-five (35) mph from the centerline of CTH KE to 0.3 miles north of the centerline of CTH KE; and

BE IT FURTHER ORDAINED that this ordinance rescinds all previous speed restrictions for the above-described portion of the County Trunk Highway System.
