WHEREAS, airport staff verified that services were performed by Wesner Development on the dates provided and in the amount being claimed, and

WHEREAS, the favorable expenditure variance resulting from the unexpended funds in 2009 through 2014 lapsed to Airport Fund Balance, and

WHEREAS, Waukesha County has reviewed these invoices and has negotiated a settlement of \$102,000 with Wesner Development for payment of these services.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the 2015 Airport Budget be amended by increasing \$102,000 of Airport Fund Balance and increasing Operating Expenses by \$102,000 to make a one-time payment to Wesner Development DBA Snow Patrol for services performed during the prior contract.

BE IT FURTHER ORDAINED that the director of the Department of Public Works is authorized to execute the necessary documents to effectuate the settlement and payment after the documents have been reviewed and approved by Corporation Counsel.
