### **Waukesha County Park System announces Public Information meeting for the Waukesha to Brookfield Connector Trail**

Waukesha, WI – Waukesha County Department of Parks and Land Use, Park System Division, invites you to attend the Public Information Meeting (PIM) at which the Waukesha to Brookfield Trail (WisDOT ID #2718-14-00) Project will be discussed. The meeting will be held at Fox Brook Park, 2925 N Barker Road, Brookfield, Wisconsin, on Thursday, December 10, 2015 beginning at 5:00 p.m. and lasting until 7 p.m. The meeting will be open-house format so you can attend any time during those hours. No formal presentation will be given, but project displays will be provided and project representatives will be available to discuss the proposed project and address any questions or concerns you may have.

The proposed trail will provide an important bike/pedestrian connection between the cities of Waukesha and Brookfield. The trail is planned to travel along CTH F south of I-94 and then within the County-owned abandoned railroad corridor north of I-94. The trail is planned to be a 10' wide asphalt pavement with 3-foot shoulders. Design strategies will minimize impacts to surrounding trees, wetlands and neighboring properties. Construction is anticipated for the summer of 2018.
