7 WHEREAS Waukesha County operates a system of county highways, and

9 WHEREAS the County has a goal of reconstructing all bridges on its system of county highways
10 that are load posted, and

12 WHEREAS the CTH TT crossing Pebble Creek was a load posted structure that was posted with
13 an 8 ton limit and was reconstructed in 2002, and

15 WHEREAS Capital Project 9907 was established to fund the needed construction, and

17 WHEREAS additional funds are needed to complete the work contemplated under this project.

19 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
20 ORDAIN that the authorized expenditure limit for Capital Project 9907 be increased by \$17,000
21 from \$512,000 to \$529,000.

23 BE IT FURTHER ORDAINED that the sum of \$17,000 be transferred from the Highway Fund
24 Balance to Capital Project 9907.
