3 AMEND THE WAUKESHA COUNTY CODE TO INCLUDE REGULATIONS FOR THE
4 COLLECTION OF ALL FEES DUE, INCLUDING REINSPECTION AND PARTIAL
5 INSPECTION FEES, PRIOR TO ISSUING OR RENEWAL OF LICENSES OF
6 ESTABLISHMENTS LICENSED UNDER THE AUTHORITY OF CHAPTER 17,
7 ARTICLE III AND ARTICLE IV OF THE WAUKESHA COUNTY CODE

10 WHEREAS the Waukesha County Board of Supervisors acknowledges the need for equitable
11 licensing fees for restaurants and retail food establishments; and
12

13 WHEREAS the Board of Supervisors further appreciates the need to effectively collect re-inspection and
14 partial inspection fees owed to Waukesha County, and
15

16 WHEREAS, the current Waukesha County Code of Ordinances provisions that regulate licensing only
17 provides that license fees shall be paid prior to license issuance or renewal and this has caused problems
18 collecting re-inspection and partial inspection fees.

20 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
21 ORDAIN THAT:
22

23 SECTION 1. Chapter 17, Article III, Health-related Regulations and Licenses, Section 17-54,
24 Fees, and Chapter 17, Article IV, Mobile Home Parks and Retail Food Establishments, Section
25 17-75, Fees, of the Waukesha County Code of Ordinances, shall be amended to include the
26 following new provision:
27

28 (i) *Licensing contingent on payment of fees.* The department may not issue or
29 renew an establishment license unless the license applicant pays all fees which are
30 due and payable under this section.
31

32 SECTION 2. This ordinance shall be effective upon approval and publication.


34 SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of
35 Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and
36 shall be appropriately renumbered to conform to the numbering system contained therein.


38 SECTION 4. Any code section or part of a section in conflict with this ordinance is hereby






