8 WHEREAS the Administrative Division of the Clerk of Circuit Court has a current vacancy in
9 the full time position of Office Services Coordinator, and

11 WHEREAS the Clerk of Circuit Court contracts with a full time consultant to provide program
12 development and coordination activities related to the Court Self Help program, and

14 WHEREAS this change in title and classification will allow the department to direct internal
15 changes and reduce costs in contracted services by providing staff oversight for both program
16 areas through one employee, and

18 WHEREAS the department wishes to recruit for this vacancy using the classification of
19 Programs and Project Analyst.

21 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
22 ORDAIN that effective the first pay period following final approval of this ordinance one regular
23 full time position of Office Services Coordinator, Step Range 7 (\$1,259.39 - \$1,609.04 biweekly)
24 shall be abolished, and one regular full time position of Programs and Projects Analyst, Step
25 Range 9 (\$1,510.31 - \$1,930.29 biweekly) in Circuit Court Services shall be created.
