AUTHORIZE SALE OF LOT ON MARINER DRIVE TO
ADJACENT PROPERTY OWNERS

WHEREAS, Armin Nankin and Al Van Ert desire to acquire a .1 acre parcel of land owned by Waukesha County, formerly known as Mariner Drive Lot, as indicated on attached Exhibit "A", and

WHEREAS, said lands are not identified for county ownership in the Waukesha County Development Plan which incorporates the Waukesha County Park and Open Space Plan as adopted by the Waukesha County Board of Supervisors on November 26, 1996, and

WHEREAS, the sale of said lands would not conflict with short or long range development plans for the Waukesha County Park System, and

WHEREAS, the fair market appraised value has been determined to be \$25,000.00.




Location Map
