3 AMEND WAUKESHA COUNTY CODE PERTAINING TO THE
4 CURRENT LIBRARY SERVICES PLAN

6 WHEREAS a library service plan is adopted by the Waukesha County Board every three years,
7 and

9 WHEREAS the inclusion of the plan years in the Waukesha County Code necessitates an
10 unnecessary Code change every three years, and
11

12 WHEREAS a review of the current Waukesha County Code reveals a need to delete the
13 specification of calendar years of the current plan.

15 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES
16 ORDAIN that:

18 SECTION 1. Section 11-4 (c)(2.) of the Waukesha County Code is hereby repealed and
19 recreated to read as follows:
20

21 Distribution of funding. When distributing the funding generated by the county,
22 the system will use the Best Fit formula elements as outlined in the current and
23 adopted Waukesha County Library Services Plan.

25 SECTION 2. This ordinance shall be effective upon approval and publication.


27 SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of

32 repealed and declared null and void and of no effect.


