6 WHEREAS the County Code was recodified by Enrolled Ordinance 157-105, and

8 WHEREAS there was no intention at the time of the recodification to remove or delete any
9 portions of the Code of Ordinances, but instead to simply reorganize the Code to make it more
10 user-friendly, and

12 WHEREAS it has been discovered that during the reorganization process Chapter 28, Water and
13 Water Quality, of the former County Code was inadvertently left out in its entirety, and


15 WHEREAS it has always been the intention of the County Board to keep all provisions of that
16 chapter in the County Code.


18 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS
19 that all of the provisions included in the former Chapter 28 of the Waukesha County Code shall
20 be included by the codifier in the current County Code and placed as a separate division in
21 Chapter 14, Parks and Land Use, of the County Code and that a copy of the former Chapter 28
22 shall be kept on file in the County Clerk's office until the passage of this ordinance.

24 BE IT FURTHER ORDAINED that, for purposes of on-going operations, all actions taken by
25 the Department of Parks and Land Use Department since adoption of the new County Code,
26 pursuant to these overlooked provisions, are hereby ratified.




