6 WHEREAS pursuant to an Order of the Division of Highways and Transportation Facilities  
7 under Section 84.09, Wisconsin Statutes, the County Highway Committee of Waukesha County  
8 acquired certain lands and interests to the same in the name of Waukesha County, Wisconsin,

11 WHEREAS the title of said lands or interests in said lands is transferable to the State of  
12 Wisconsin upon Order of the Division of Highway and Transportation Facilities to the County  
13 Clerk and the County Highway Committee, and

15 WHEREAS the Division of Highway and Transportation Facilities issued an order for transfer of  
16 title to the properties described below on August 19, 2003.

18 THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES  
19 ORDAIN that the Waukesha County Clerk and County Executive shall execute the documents  
20 required to convey to the State of Wisconsin, without charge, the title or easement acquired with  
21 the following parcels of the Division of Highways and Transportation Facilities project

## FISCAL NOTE

### CONVEY TITLE TO HIGHWAY RIGHT OF WAY TO THE STATE OF WISCONSIN

Section 84.09(3) of the Wisconsin Statutes authorizes the State Department of Transportation to order counties to acquire land or interests in land, with the title to the property conveyed to the counties. The same section also authorizes the State Department of Transportation to order counties to convey title of property so acquired to the State at no charge.

The property identified in this ordinance was acquired with State funds in 1941 pursuant to a State order, and an order has been received to convey title to the property from the County to the State.

There is no direct fiscal impact as a result of this ordinance.




Parcel
