

ENROLLED ORDINANCE 159-123

AMEND SHERIFF'S DEPARTMENT 2005 BUDGET
EXPENDITURE OF DONATED FUNDS

WHEREAS, the Sheriff's Department is retiring one of its canine units, and

WHEREAS, the department has endeavored to purchase replacement dogs through donated funds, and

WHEREAS, the department has accumulated sufficient donated funds in prior years to now purchase a replacement canine, provide dog and handler training, and squad bailout equipment.


THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY DOES ORDAIN that the Waukesha County Sheriff's Department 2005 budget be modified by appropriating reserved General Fund balance by an amount not to exceed \$18,500, and authorizing the appropriation of an identical amount by increasing related Fixed Asset, Operating Expense, and Personnel Cost_appropriations to fund the purchase, training and equipment of a replacement canine unit.

BE IT FURTHER ORDAINED that modifications to the Sheriff's 2005 budget appropriations be authorized up to, but not exceeding a total of \$18,500, based on actual expenditures made by the Sheriff department.


