

ENROLLED ORDINANCE 159-31

ORDER TO CONVEY TITLE TO HIGHWAY RIGHT OF WAY
TO THE STATE OF WISCONSIN
PROJECT FI 056-1(13) PARCEL 34

WHEREAS, pursuant to an Order of the Division of Highways and Transportation Facilities under Section 84.09, Wisconsin Statutes, the County Highway Committee of Waukesha County acquired certain lands and interests to the same in the name of Waukesha County, Wisconsin, and

WHEREAS the acquired certain lands and interests were purchased with State funding for State projects, and

WHEREAS, also under Section 84.09, Wisconsin Statutes, the title of said lands or interests in said lands is transferable to the State of Wisconsin, at no charge, upon Order of the Division of Highway and Transportation Facilities to the County Clerk and the County Highway Committee, and

WHEREAS the Division of Highway and Transportation Facilities issued an order for transfer of title to the properties described below on May 4, 2004.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the Waukesha County Clerk and County Executive shall execute the documents required to convey to the State of Wisconsin, without charge, the title or easement acquired with the following parcels of the Division of Highway and Transportation Facilities projects designated as:


