

ENROLLED ORDINANCE 159-84

EXTENSION OF TIME PERIOD FOR RETENTION PAYMENTS TO
TELECOMMUNICATORS TRANSITIONING TO COUNTY EMPLOYMENT

WHEREAS the Waukesha County Board adopted Ordinance #158-20 to address the change in benefit transition issues for the dispatchers from the City of Brookfield to the Consolidated Communications Center, and

WHEREAS the Ordinance provided that Telecommunicators who were employed with the County prior to December 15, 2004 and who have successfully completed the required probationary period would be eligible for a one time retention compensation payment of \$500, and

WHEREAS the City of Brookfield Telecommunicators will have their employment with the County commence after the initial time period established in the original ordinance, and

WHEREAS it was the intent of Ordinance #158-20 to provide this retention benefit to those employees.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that Telecommunicators who are currently employed with the City of Brookfield and who commence their employment with the County of Waukesha effective January 1, 2005 will be eligible for a one time retention compensation payment of \$500 after they have successfully completed the required six (6) month probationary period.


